1. GRANTEE: Olin Corporation  
Oxford, MS
2. PURPOSE AND LIMITATION:
  - a. This special permit authorizes the transportation in commerce of certain Division 1.4S small arms cartridges in non-DOT specification bulk packagings without labels and markings, subject to the limitations and special requirements specified herein. This special permit provides no relief from the Hazardous Materials Regulations (HMR) other than as specifically stated herein. The most recent revision supersedes all previous revisions.
  - b. The safety analyses performed in the development of this special permit only considered the hazards and risks associated with the transportation in commerce.
  - c. No party status will be granted to this special permit.
3. REGULATORY SYSTEM AFFECTED: 49 CFR Parts 106, 107 and 171-180.
4. REGULATIONS FROM WHICH EXEMPTED: 49 CFR § 172.101, column (8C) in that bulk packagings are not authorized for Cartridges, small arms, Part 172 Subpart D Marking, and Part 172 Subpart E Labeling, except as provided herein.
5. BASIS: This special permit is based on the application of Olin Corporation dated March 29, 2013, submitted in accordance with § 107.105, and the public proceeding thereon.

7. SAFETY CONTROL MEASURES:

a. PACKAGING - Cartridges, small arms must be placed in a non-specification reusable corrugated steel bulk bins with removable plastic or metal covers. The net weight of articles may not exceed 4000 pounds per bin. These bins must meet the drop test criteria for UN 11A intermediate bulk containers at the Packing Group II performance level.

b. OPERATIONAL CONTROLS:

(1) Transportation in commerce under this special permit is limited to the Olin Corporation, Winchester Division facilities at Oxford, MS and East Alton, IL and the Abilities Works and Challenge Unlimited locations at Alton, IL and Swansea, IL for a distance not to exceed 395 miles on a public highway between the facilities.

(2) All packages shipped under this special permit must be transported by Olin Corporation/Winchester Division's specially designed company-owned or leased cargo motor vehicles and cargo trailers operated by company employees, or by a contract carrier under the exclusive use of Olin Corporation.

(3) All Cartridges, small arms transported under this permit must meet the requirements of § 173.56(h) to be classed as Division 1.4S and does not require any further approval from the Associate Administrator.

8. SPECIAL PROVISIONS: A current copy of this special permit must be maintained at each facility where the package is

offered or reoffered for transportation.

9. MODES OF TRANSPORTATION AUTHORIZED: Motor vehicle.
10. MODAL REQUIREMENTS: A current copy of this special permit must be carried aboard each motor vehicle used to transport packages covered by this special permit.
11. COMPLIANCE: Failure by a person to comply with any of the following may result in suspension or revocation of this special permit and penalties prescribed by the Federal hazardous materials transportation law, 49 U.S.C. 5101 et seq:
  - o All terms and conditions prescribed in this special permit and the Hazardous Materials Regulations, 49 CFR Parts 171-180.
  - o Persons operating under the terms of this special permit must comply with the security plan requirement in Subpart I of Part 172 of the HMR, when applicable.
  - o Registration required by § 107.601 et seq., when applicable.

Each "Hazmat employee", as defined in § 171.8, who performs a function subject to this special permit must receive training on the requirements and conditions of this special permit in addition to the training required by §§ 172.700 through 172.704.

No person may use or apply this special permit, including display of its number, when this special permit has expired or is otherwise no longer in effect.

Under Title VII of the Safe, Accountable, Flexible, Efficient Transportation Equity Act: A Legacy for Users (SAFETEA-LU)—"The Hazardous Materials Safety and Security Reauthorization Act of 2005" (Pub. L. 109-59), 119 Stat. 1144 (August 10, 2005), amended the Federal hazardous materials transportation law by changing the term "exemption" to "special permit" and authorizes a special permit to be granted up to two years for new special permits and up to four years for renewals.

12. REPORTING REQUIREMENTS: Shipments or operations conducted under this special permit are subject to the Hazardous Materials Incident Reporting requirements specified in 49 CFR §§ 171.15 Immediate notice of certain hazardous materials incidents, and 171.16 Detailed hazardous materials incident reports. In addition, the grantee(s) of this special permit must notify the Associate Administrator for Hazardous Materials Safety, in writing, of any incident involving a package, shipment or operation conducted under terms of this special permit.
