1. GRANTEE: (See individual authorization letter)

2. PURPOSE AND LIMITATION:

a. This special permit authorizes the offering in commerce of Fireworks, Division 1.3G, UN0335, which are forbidden for transportation by cargo aircraft, only within the State of Alaska where no other means of transportation is available. This special permit provides no relief from the Hazardous Materials Regulations (HMR) other than as specifically stated herein. The most recent revision supersedes all previous revisions.

b. The safety analyses performed in development of this special permit only considered the hazards and risks associated with transportation in commerce.

c. Unless otherwise stated herein, this special permit consists of the special permit authorization letter issued to the grantee together with this document.

- 3. <u>REGULATORY SYSTEM AFFECTED</u>: 49 CFR Parts 106, 107 and 171-180.
- 4. <u>REGULATIONS FROM WHICH EXEMPTED:</u> 49 CFR Table § 172.101, Column (9B), § 172.204(c)(3), and § 173.27(b)(2), and (3) in that the explosive is forbidden for transportation by cargo aircraft, except as provide herein.
- 5. <u>BASIS</u>: This special permit is based on the application of Lantis Productions Inc. dba Lantis Fireworks & Lasers dated May 15, 2012 submitted in accordance with § 107.105 and the public proceeding thereon.

6. HAZARDOUS MATERIALS (49 CFR § 172.101):

The above description applies only to fireworks that have been approved pursuant to 173.56.

7. SAFETY CONTROL MEASURES:

a. <u>PACKAGING</u> - Packaging is as prescribed in § 173.62 except that inner packagings must be bags or receptacles that can be tightly sealed to prevent the release of pyrotechnic powders to the outer packaging.

b. <u>Authorized explosives</u>: Division 1.3 explosives that are not permitted for shipment by air in 49 CFR Parts 171 through 180, may be offered for transportation by cargo aircraft.

c. This special permit is authorized for use only within the State of Alaska where no other means of transportation is available.

d. The air carrier used to transport forbidden explosives must hold a valid special permit authorizing such transportation.

8. SPECIAL PROVISIONS:

a. A person who is not a holder of this special permit who receives a package covered by this special permit may reoffer it for transportation provided no modification or change is made to the package and it is reoffered for transportation in conformance with this special permit and the HMR.

b. A current copy of this special permit must be maintained at each facility where the package is offered or reoffered for transportation.

- 9. MODES OF TRANSPORTATION AUTHORIZED: Cargo aircraft only.
- 10. <u>MODAL REQUIREMENTS</u>: The shipper must furnish a copy of this special permit to the air carrier before or at the time the shipment is tendered.
- 11. <u>COMPLIANCE</u>: Failure by a person to comply with any of the following may result in suspension or revocation of this special permit and penalties prescribed by the Federal hazardous materials transportation law, 49 U.S.C. 5101 <u>et</u> seq:
 - All terms and conditions prescribed in this special permit and the Hazardous Materials Regulations, 49 CFR Parts 171-180.
 - Persons operating under the terms of this special permit must comply with the security plan requirement in Subpart I of Part 172 of the HMR, when applicable.
 - o Registration required by § 107.601 <u>et seq</u>., when applicable.

Each "Hazmat employee", as defined in § 171.8, who performs a function subject to this special permit must receive training on the requirements and conditions of this special permit in addition to the training required by §§ 172.700 through 172.704.

No person may use or apply this special permit, including display of its number, when this special permit has expired or is otherwise no longer in effect.

Under Title VII of the Safe, Accountable, Flexible, Efficient Transportation Equity Act: A Legacy for Users (SAFETEA-LU)—"The Hazardous Materials Safety and Security Reauthorization Act of 2005" (Pub. L. 109-59), 119 Stat. 1144 (August 10, 2005), amended the Federal hazardous materials transportation law by changing the term "exemption" to "special permit" and authorizes a special permit to be granted up to two years for new special permits and up to four years for renewals.

12. <u>REPORTING REQUIREMENTS</u>: Shipments or operations conducted under this special permit are subject to the Hazardous Materials Incident Reporting requirements specified in 49 CFR §§ 171.15 Immediate notice of certain hazardous materials incidents, and 171.16 Detailed hazardous materials incident reports. In addition, the grantee(s) of this special permit must notify the Associate Administrator for Hazardous Materials Safety, in writing, of any incident involving a package, shipment or operation conducted under terms of this special permit.
