- 1. GRANTEE: (See individual authorization letter)
- 2. PURPOSE AND LIMITATION:
 - a. This special permit authorizes the transportation in commerce of certain solvents in previously used steel drums without leakproof testing. This special permit provides no relief from the Hazardous Materials Regulations (HMR) other than as specifically stated herein. The most recent revision supersedes all previous revisions.
 - b. The safety analyses performed in the development of this special permit only considered the hazards and risks associated with the transportation in commerce.
 - c. Unless otherwise stated herein, this special permit consists of the special permit authorization letter issued to the grantee together with this document.
- 3. REGULATORY SYSTEM AFFECTED: 49 CFR Parts 106, 107 and 171-180.
- 4. REGULATIONS FROM WHICH EXEMPTED: 49 CFR § 173.28(b)(7)(iii)(C), in that each drum must be leakproof tested prior to reuse, except as provided herein.
- 5. BASIS: This special permit is based on the Pipeline and Hazardous Materials Safety Administration's (PHMSA) editorial review under § 107.121 initiated on December 4, 2008 and application for CA1995090017 on file with the Office of Hazardous Materials Approvals and Permits.

6. HAZARDOUS MATERIALS (49 CFR § 172.101):

7. SAFETY CONTROL MEASURES: PACKAGING:

- a. The authorized packaging is a UN 1A2 steel drum tested and certified to the PGII level with a minimum thickness of 0.9 mm and maximum capacity of 30 gallons.
- b. These drums may be reused for the transportation of solvents, without being subjected to the leakproofness test of 49 CFR 173.28(b)(2), subject to the following conditions:
 - (1) Inspection/rejection criteria: Each drum shall be inspected for leakage before refilling and shipment. Any evidence of leakage requires that the drum be removed from service. In addition, inspection of general drum conditions shall be in accordance with your "Recommended Container Management Guidelines" submitted in the application dated September 18, 1996, and each drum not in compliance with this guideline must be removed from service.
 - (2) Transportation is authorized by private carriage only. Each vehicle used in the transportation of these drums must have a means of containment sufficient to contain 30 gallons of solvent.
 - (3) A drum may not be loaded to more than 75% (three-quarters) of its total capacity.

8. SPECIAL PROVISIONS:

- a. A current copy of this approval must be maintained and made available for examination at each location where refilling of drums which have not been leakproofness tested takes place.
- b. Any person who re-offers for transportation or transports the above-described package(s) may do so under the authority of this approval if all requirements and conditions of this approval are met.
- c. A person who is not a holder of this special permit who receives a package covered by this special permit may reoffer it for transportation provided no modification or change is made to the package or its contents and it is reoffered for transportation in conformance with this special permit and the HMR.
- d. A current copy of this special permit must be maintained at each facility where the package is offered or reoffered for transportation.
- 9. MODES OF TRANSPORTATION AUTHORIZED: Motor Vehicle.
- 10. MODAL REQUIREMENTS: A current copy of this special permit must be carried aboard each motor vehicle used to transport packages covered by this special permit.
- 11. <u>COMPLIANCE</u>: Failure by a person to comply with any of the following may result in suspension or revocation of this special permit and penalties prescribed by the Federal hazardous materials transportation law, 49 U.S.C. 5101 <u>et</u> seq:
 - o All terms and conditions prescribed in this special permit and the Hazardous Materials Regulations, 49 CFR Parts 171-180.
 - o Persons operating under the terms of this special permit must comply with the security plan requirement in Subpart I of Part 172 of the HMR, when applicable.
 - o Registration required by § 107.601 et seq., when applicable.

Each "Hazmat employee", as defined in § 171.8, who performs a function subject to this special permit must receive training on the requirements and conditions of this special permit in addition to the training required by §§ 172.700 through 172.704.

No person may use or apply this special permit, including display of its number, when this special permit has expired or is otherwise no longer in effect.

Under Title VII of the Safe, Accountable, Flexible, Efficient Transportation Equity Act: A Legacy for Users (SAFETEA-LU)—"The Hazardous Materials Safety and Security Reauthorization Act of 2005" (Pub. L. 109-59), 119 Stat. 1144 (August 10, 2005), amended the Federal hazardous materials transportation law by changing the term "exemption" to "special permit" and authorizes a special permit to be granted up to two years for new special permits and up to four years for renewals.

12. REPORTING REQUIREMENTS: Shipments or operations conducted under this special permit are subject to the Hazardous Materials Incident Reporting requirements specified in 49 CFR §§ 171.15 Immediate notice of certain hazardous materials incidents, and 171.16 Detailed hazardous materials incident reports. In addition, the grantee(s) of this special permit must notify the Associate Administrator for Hazardous Materials Safety, in writing, of any incident involving a package, shipment or operation conducted under terms of this special permit.
