Dear Secretary LaHood:

The Kansas Department of Transportation has reviewed its Maintenance of Effort certification, initially submitted on March 19, 2009, and has determined that a revised certification must be submitted. Based on this revision and pursuant to Title XII, Section 1201 of the American Recovery and Reinvestment Act (ARRA) of 2009 (P.L. 111-5, Feb. 17, 2009), I hereby certify that the State of Kansas will maintain its effort with regard to State funding for the types of projects in the U.S. Department of Transportation's "covered programs" funded under ARRA.

As required, the attached comprehensive list identifies the amount of funds the State of Kansas plans to expend from State sources from February 17, 2009 to September 30, 2010, for the types of projects under all the DOT "covered programs" funded by ARRA. In summary, the State planned to expend the following amounts for the DOT programs indicated for the period February 17, 2009 through September 30, 2010:

> Highway infrastructure projects = \$586.8 million Transit capital projects = \$5.8 million

I understand that if the State of Kansas is unable to maintain the level of funding as identified under the DOT "covered programs" funded under ARRA, that the State will be prohibited by the Secretary of Transportation from receiving additional limitation on obligations for Federal-aid highway and highway safety construction programs that occurs after August 1 for Federal fiscal year 2011.
