Pursuant to Title XII, section 1201 of the American Recovery and Reinvestment Act (Pub. L. 111-5 (Feb. 17, 2009)) ("ARRA"), I, Donald L. Carcieri, the Governor of the State of Rhode Island, hereby certify to the Secretary of Transportation that the State of Rhode Island will maintain its effort with regard to State funding for the types of projects in Rhode Island Airport Corporation ("RIAC") "covered programs" funded under ARRA.

The attached list of RIAC "covered programs" identifies the amount of funds the State plans to expend from State sources from February 17, 2009 to September 30, 2010, for the types of projects under the RIAC "covered programs" funded under ARRA.
