

Pursuant to Title XV, Subtitle A, Section 1511 of the American Recovery and Reinvestment Act (Pub. I understand that my state or local agency may not receive ARRA infrastructure investment funding unless this certification is made and posted.



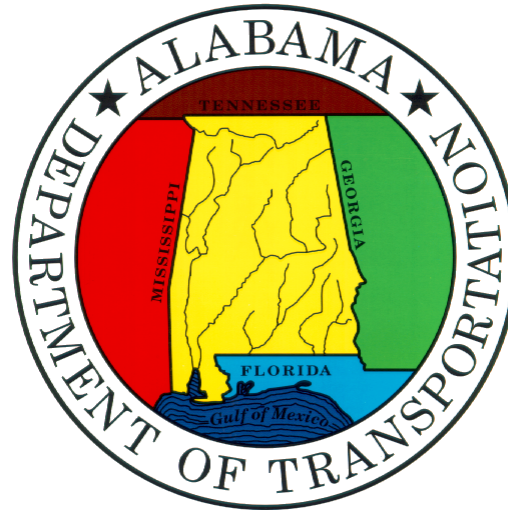

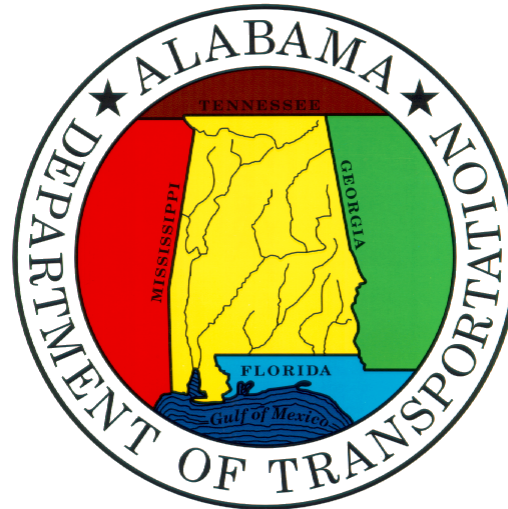
