SELECTED HIGHWAY STATISTICS AND CHARTS -- 1990

MOTOR FUEL - Highway Use of Gasoline up 0.3 Percent; Special Fuels Use up 0.6 Percent

Highway use of motor fuel in 1990 totaled 131.6 billion gallons, a decrease of 0.2 percent from 1989. In 1991, highway use of motor fuel is expected to decrease by about 1.3 percent. Net State motor-fuel tax revenues increased 5.5 percent from 1989, reflecting a number of tax increases in 1990. State motor-fuel tax revenues are expected to increase 5.1 percent in 1991 despite the projected decrease in fuel usage as additional State tax rate increases take effect.

The gasoline tax rate changed in 17 States during 1990. Twelve of the changes were legislated increases. The remaining five States have variable rate taxes which are adjusted at regular intervals based on changes in the average wholesale price of gasoline, the consumer price index, or another indicator as specified in the State tax law.

MOTOR-VEHICLE REGISTRATIONS - Total Motor-Vehicle Registrations Exceed 188 Million in 1990

Motor-vehicle registrations in the Nation increased from 187,260,547 in 1989 to 188,655,462 in 1990, an increase of 0.7 percent. Motor-vehicle and motor-carrier revenues increased 3.5 percent. Motor-vehicle registrations for 1991 are expected to exceed those in 1990 by 1.1 percent for a total of 190,741,000. Motor-vehicle and motor-carrier revenues are expected to increase by 1.5 percent in 1991.

DRIVER LICENSING - Number of Licensed Drivers Up 0.9 Percent

The total number of licensed drivers has increased from 165.9 million for 1989 to 167.0 million for 1990--a 0.9 percent increase. Although the middle age group (age 40-44) shows a large increase in drivers compared to 10 years ago (51.8 percent), the most drastic increase for the same period of time is still in the older drivers group (70 and over--56.1 percent).

HIGHWAY FINANCE - Total Highway Expenditures Increased by \$3.9 Billion in 1990

Highway-user imposts, consisting of motor-fuel taxes, motor-vehicle taxes and fees, and highway tolls, increased by \$94 million from 1989 to 1990. Those revenues totaled \$44.2 billion and accounted for 59.8 percent of total receipts for highways by all units of government in 1990. Total receipts were \$73.9 billion, an increase of \$1.2 billion over 1989. Receipts from nonuser sources--general fund revenues, property taxes, investment income and miscellaneous receipts--totaled \$24.3 billion, a 3.5 percent increase from 1989. Bond proceeds for 1990 were \$5.4 billion, an increase of \$220 million from 1989.

Total highway expenditures amounted to \$74.8 billion in 1990, up \$3.9 billion from 1989. Capital outlay increased by \$2.3 billion, or 6.8 percent, to \$35.4 billion. Inflation in 1990 highway construction prices reduced the increase in real expenditures to 6 percent for highway capital outlay. Expenditures for highway maintenance and traffic services amounted to \$19.7 billion, an increase of \$789 million, or 4.2 percent; however, inflation held real expenditures to the 1989 level.

For the 50 States and the District of Columbia, highway-user imposts accounted for 77.5 percent of the \$39.4 billion in State highway receipts for 1990. State highway receipts from user fees increased by \$1.7 billion while receipts from nonuser sources increased by \$226 million. Nonuser sources accounted for 14.4 percent of State receipts for highways. Bond proceeds totaled \$3.2 billion, an increase of \$133 million from 1989. Bond proceeds exclude refunding. State highway programs totaled \$45.6 billion (excluding grants-in-aid to local governments) for 1990, an increase of \$2.6 billion over 1989. Highway capital outlay--\$26.3 billion--accounted for 57.6 percent of total State highway expenditures.

ROADWAY MILEAGE AND HIGHWAY TRAVEL - Travel Up 2.4 Percent

Public roads and streets in the United States, as of December 31, 1990, totaled approximately 3.88 million miles, an increase of 0.1 percent from 1989.

Highway travel in the United States increased to an estimated 2,148 billion vehicle-miles--an increase of about 2.4 percent from 1989.

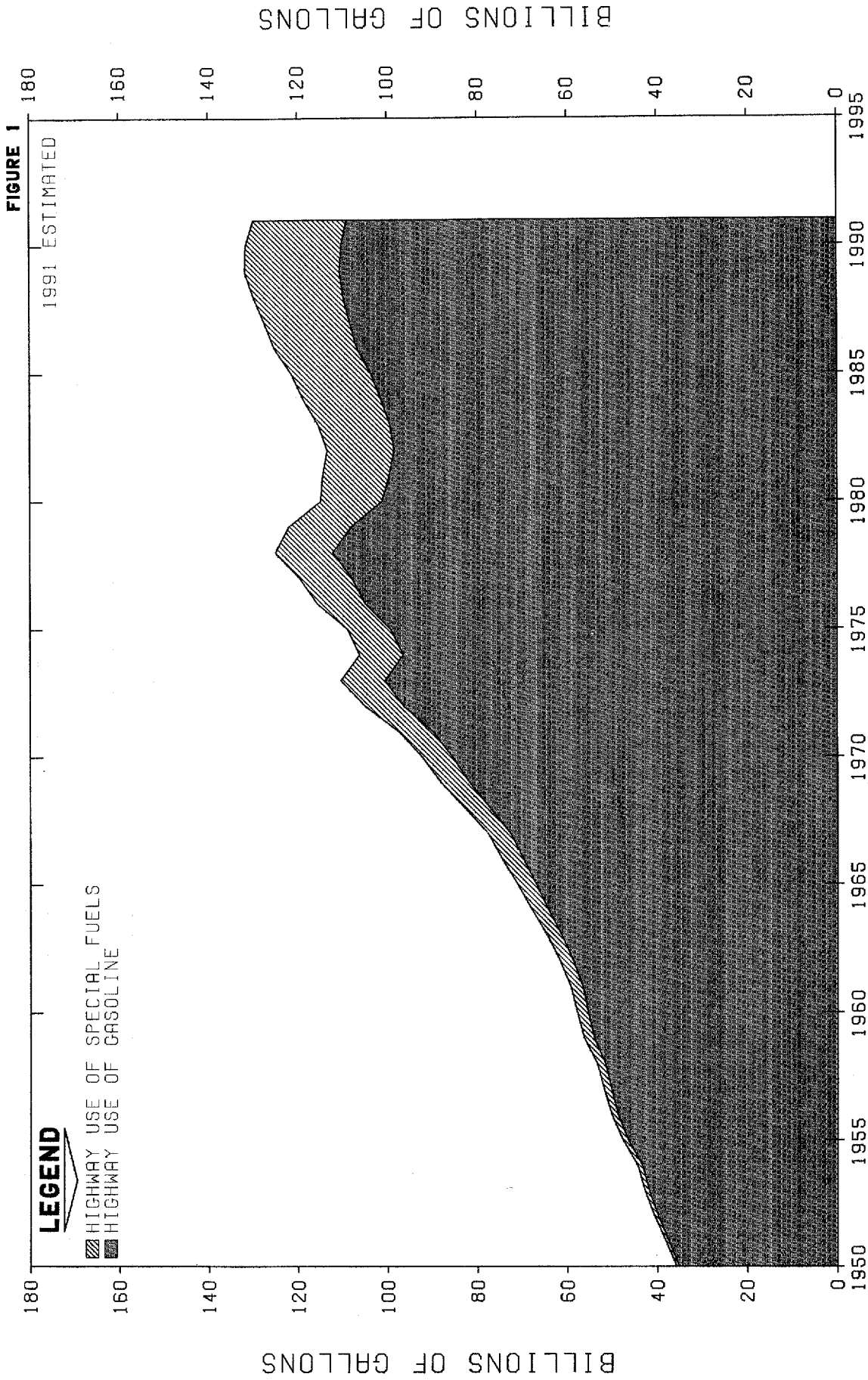
The Interstate System accounts for about 1 percent of the Nation's total route mileage and carries 22 percent of the travel. The arterial class highways (including Interstate) represent 11 percent of the mileage and carry 70 percent of the travel. All arterial and collector highways combined, which include 31 percent of the Nation's mileage, carry 86 percent of the travel.

Congestion on the urban Interstate System has steadily become worse. In the period 1981 to 1990, the percentage of mileage affected during the peak travel hour increased from 25 percent to 45 percent. In the same period, the percentage of peak hour vehicle-miles affected increased from 49 percent to 69 percent.

MISCELLANEOUS - Expenditures per mile averaged \$29,560 and \$9,010 for capital outlay and maintenance, respectively. State highway-user revenue per 1,000 vehicle-miles of travel averaged \$16.73 for all States.

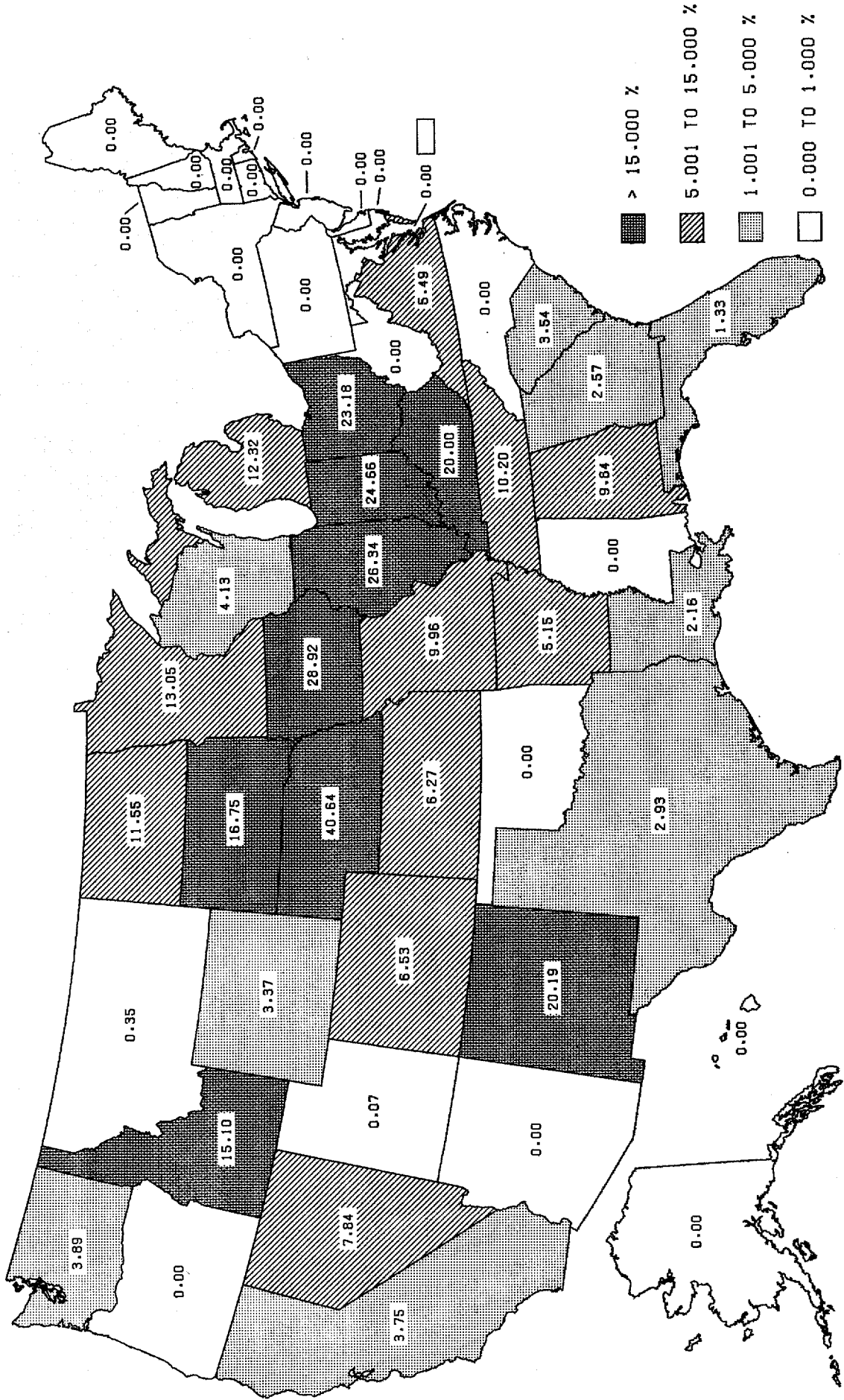

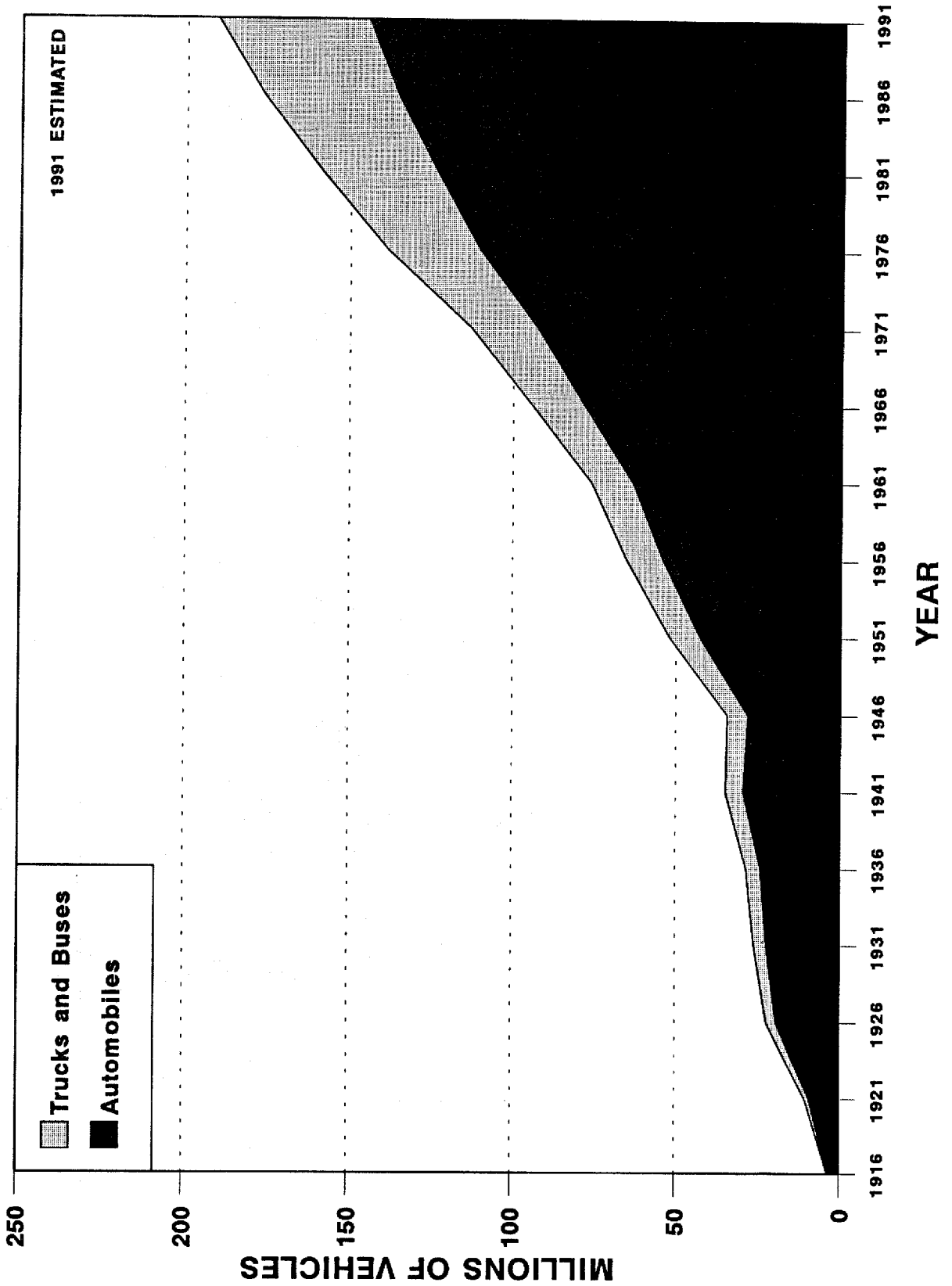
GASOLIN AS A PERCENT OF HIGHWAY USE OF GASOLINE - 1990

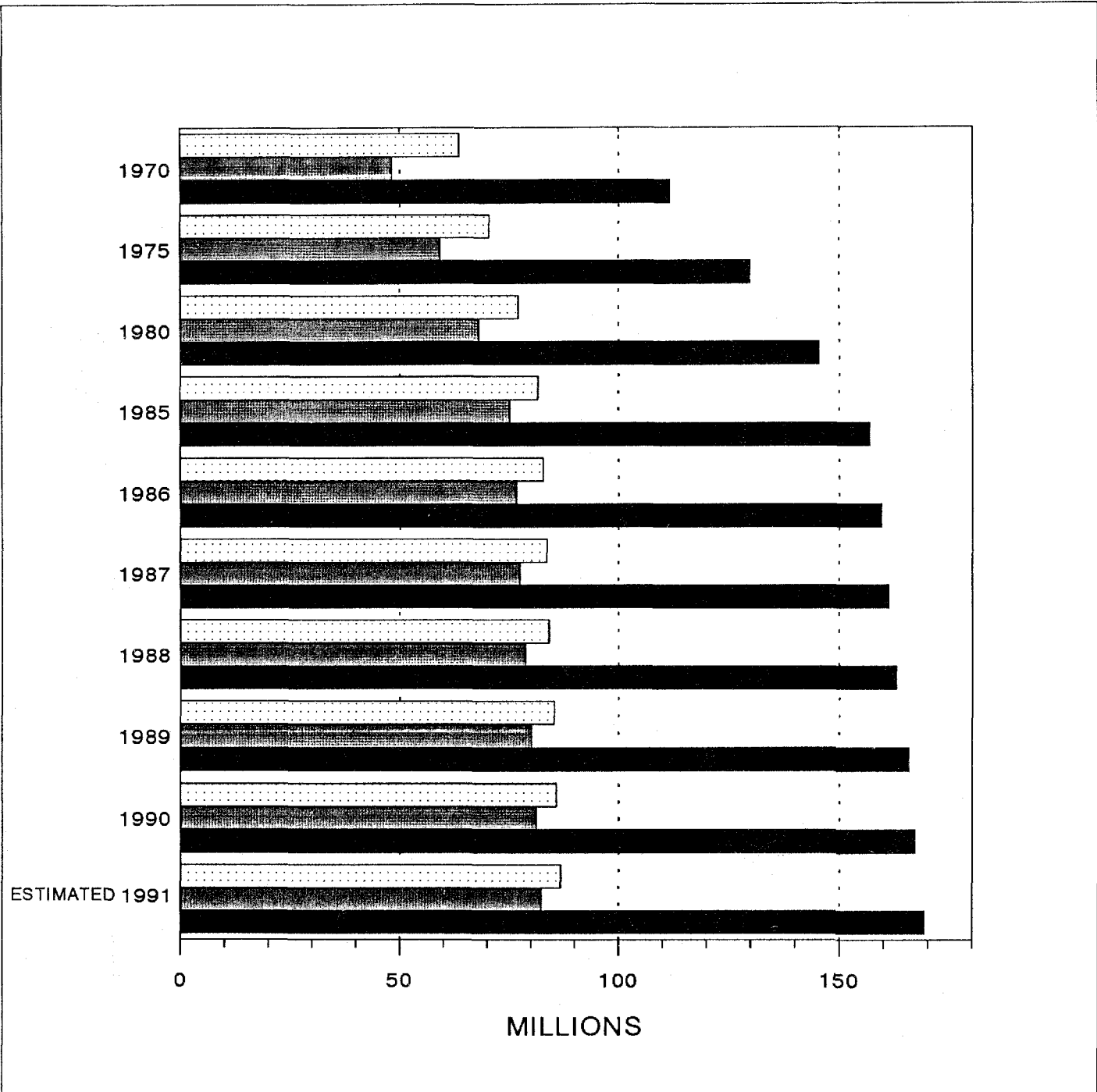

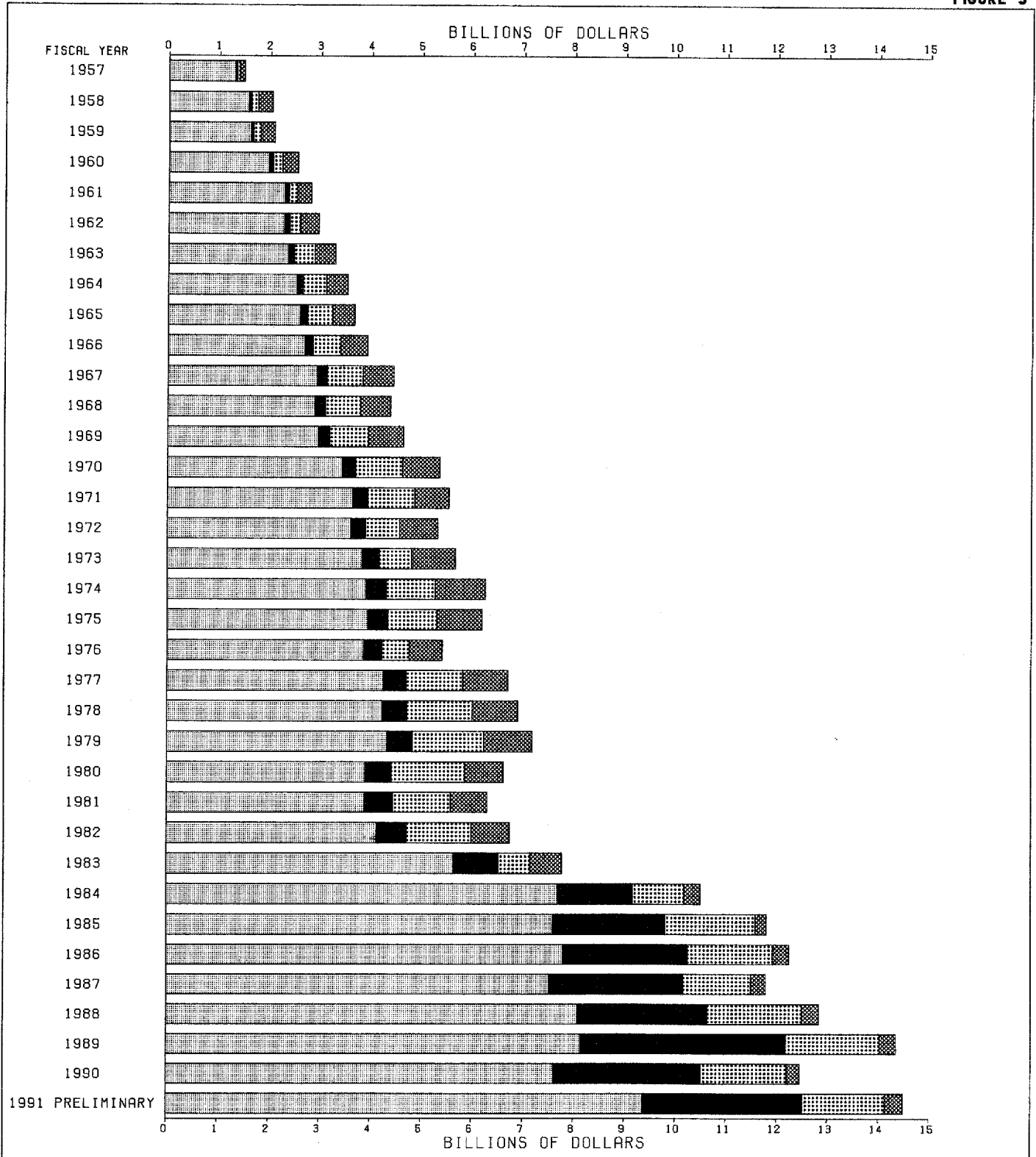

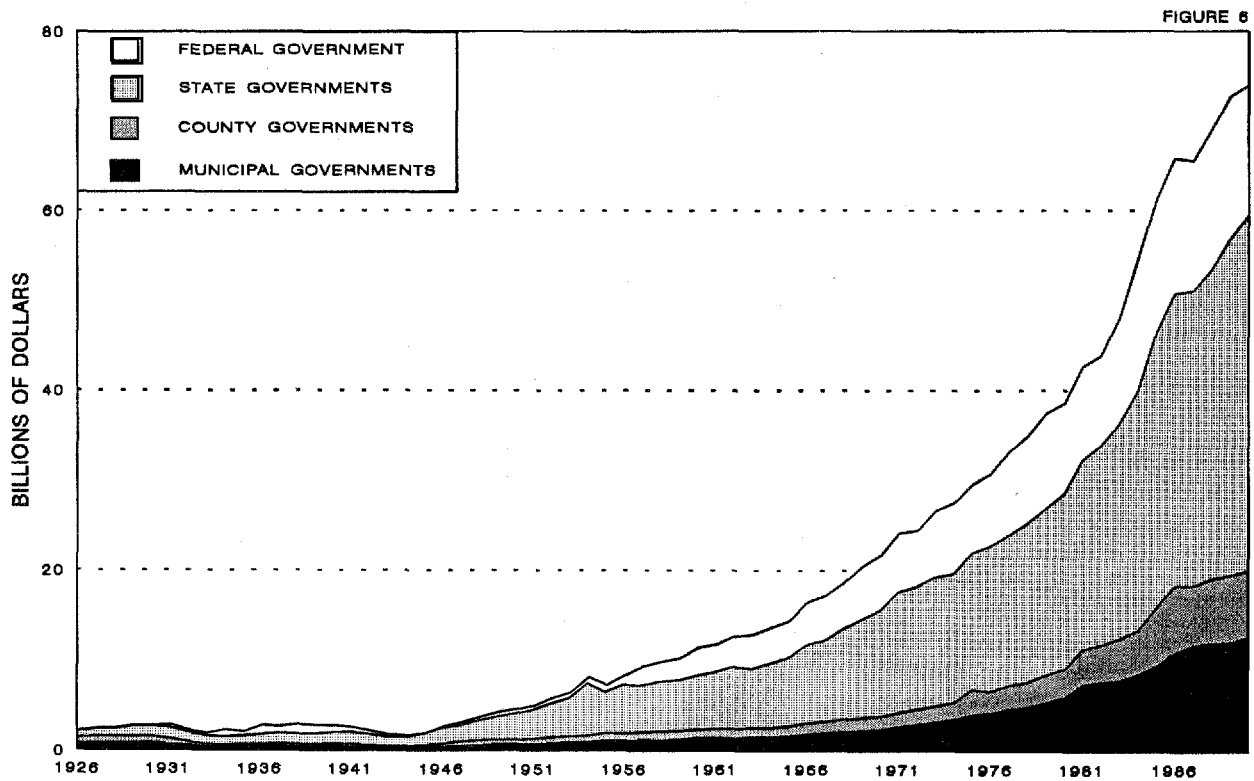

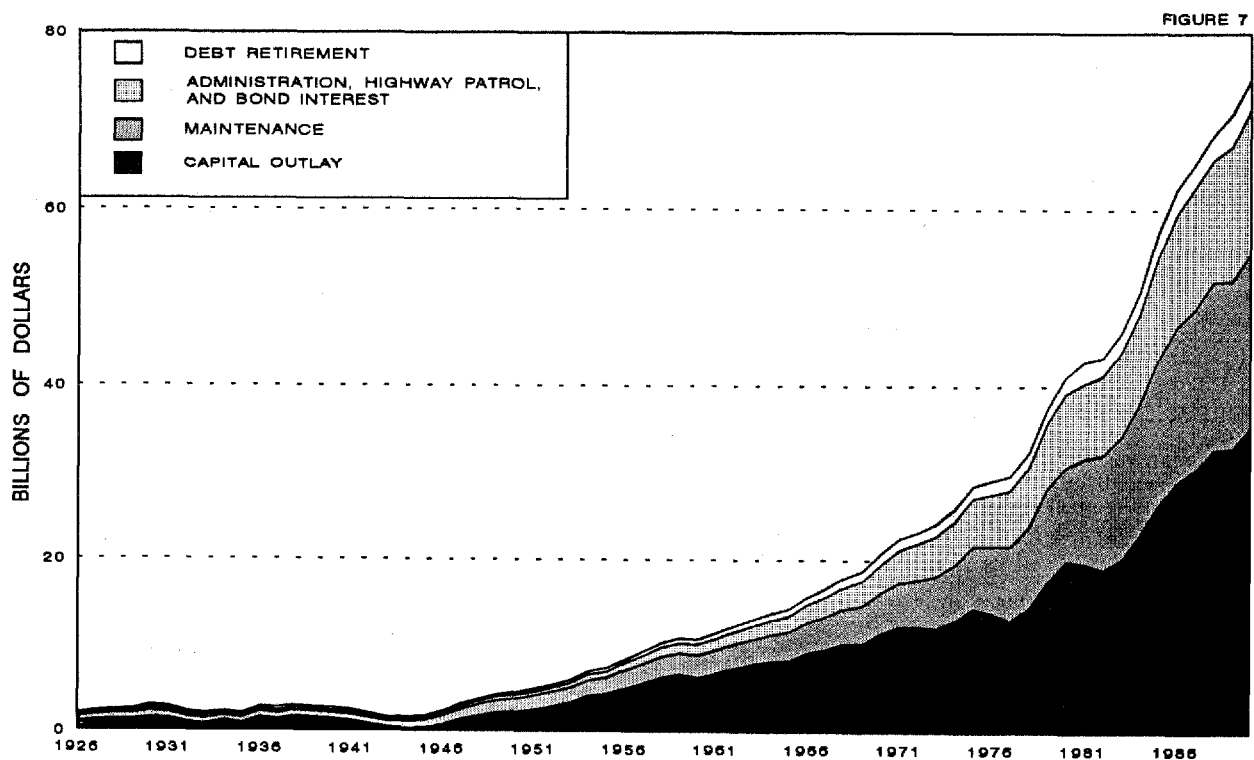

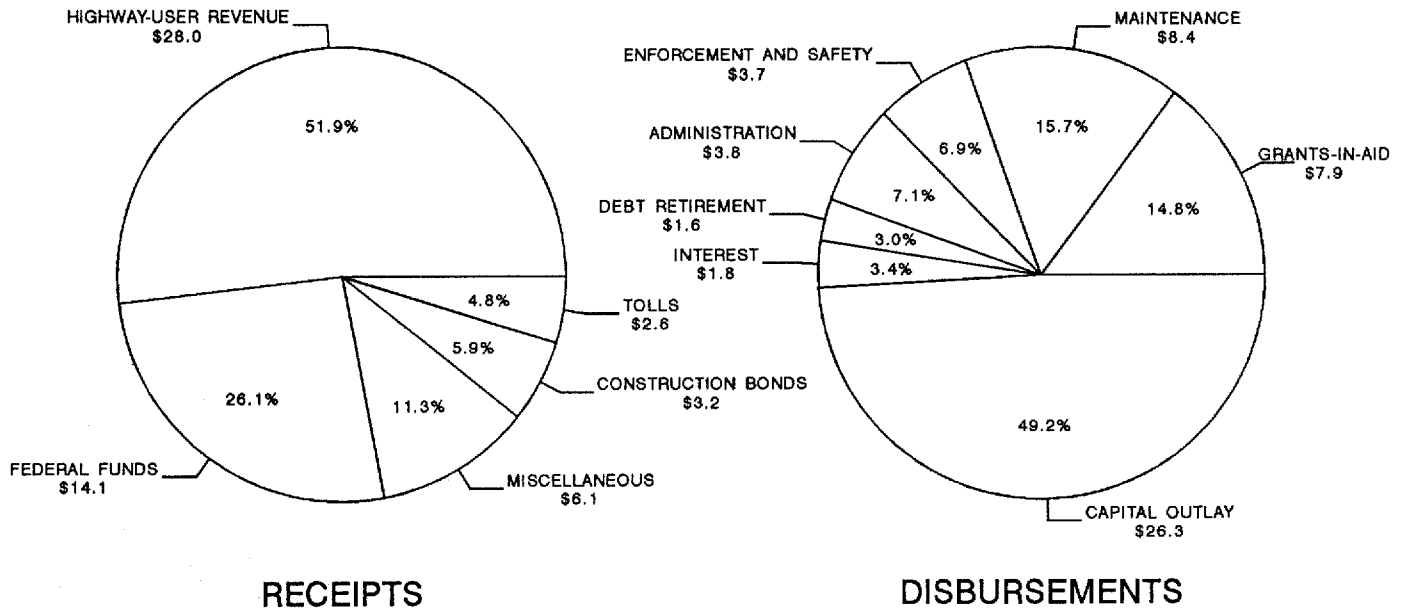

STATE RECEIPTS AND DISBURSEMENTS FOR HIGHWAYS - 1990 (BILLIONS OF DOLLARS)



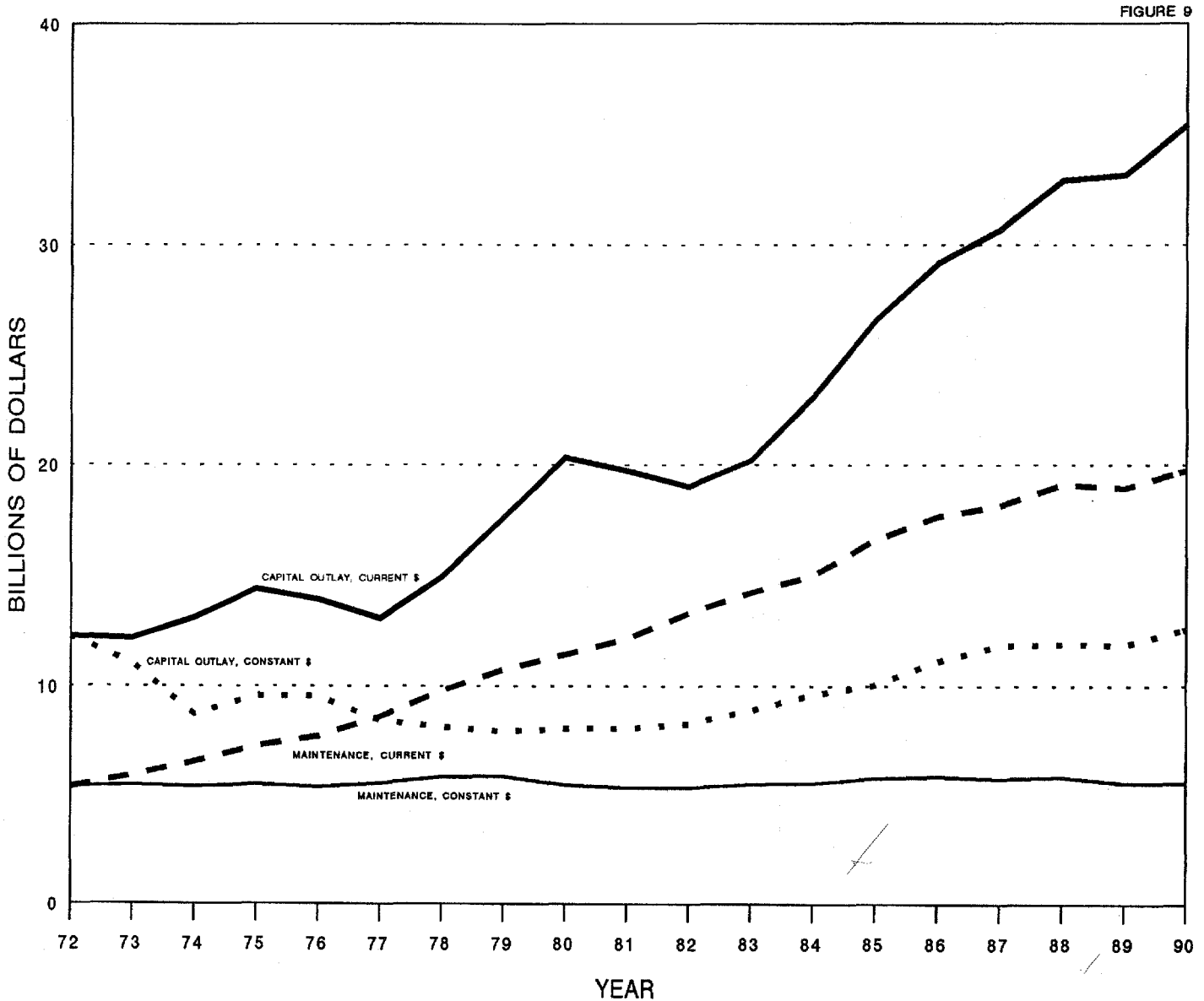

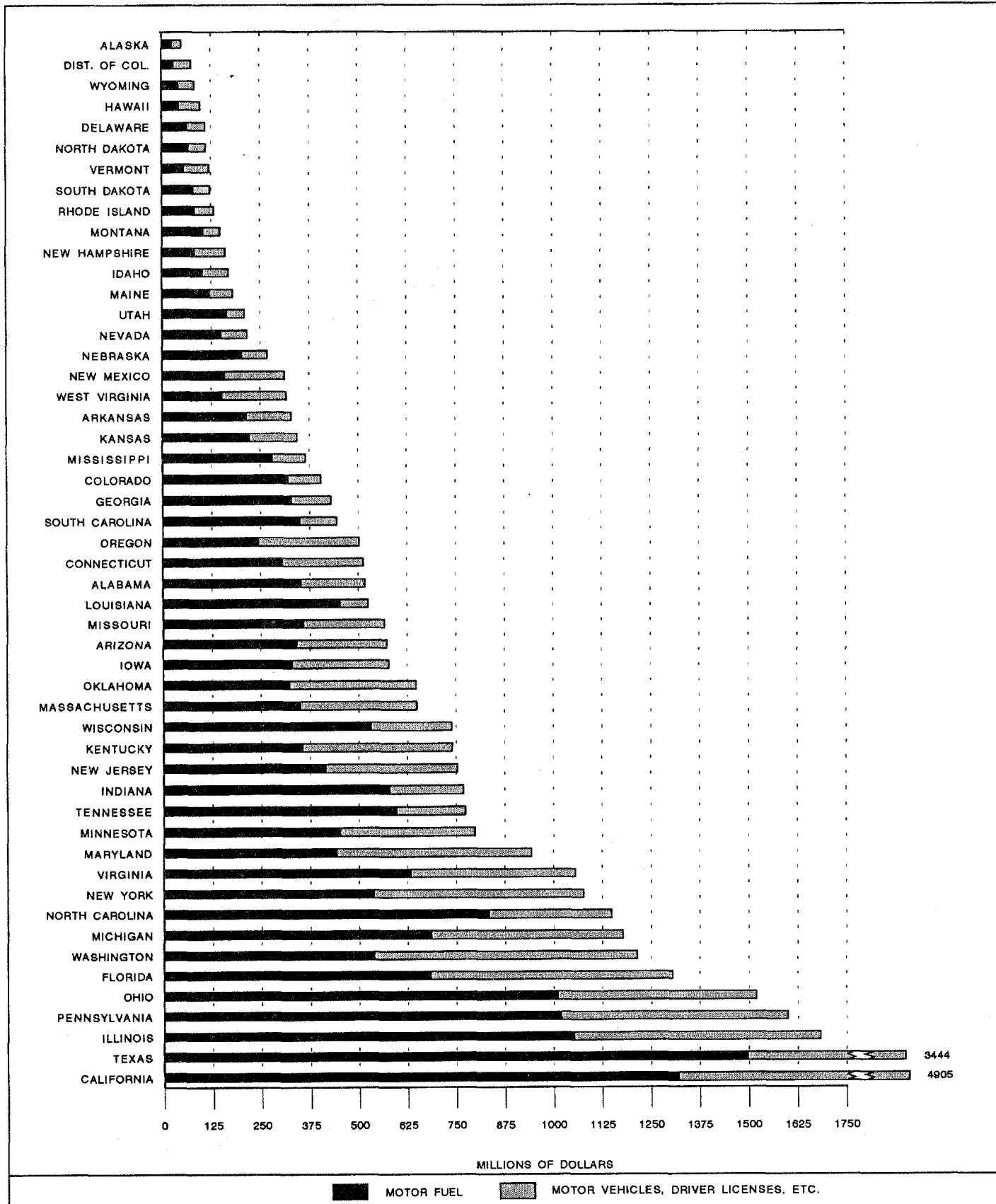

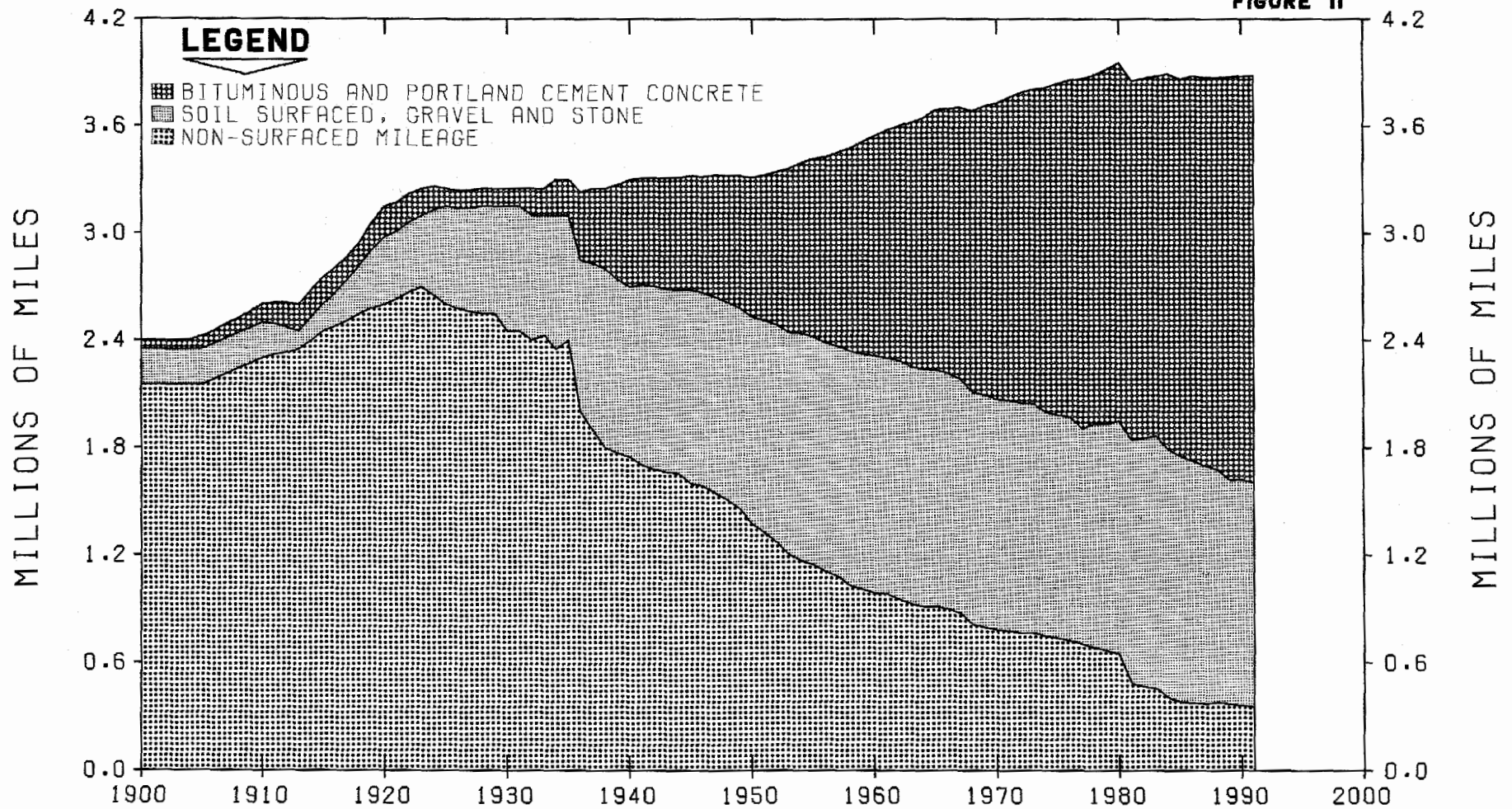

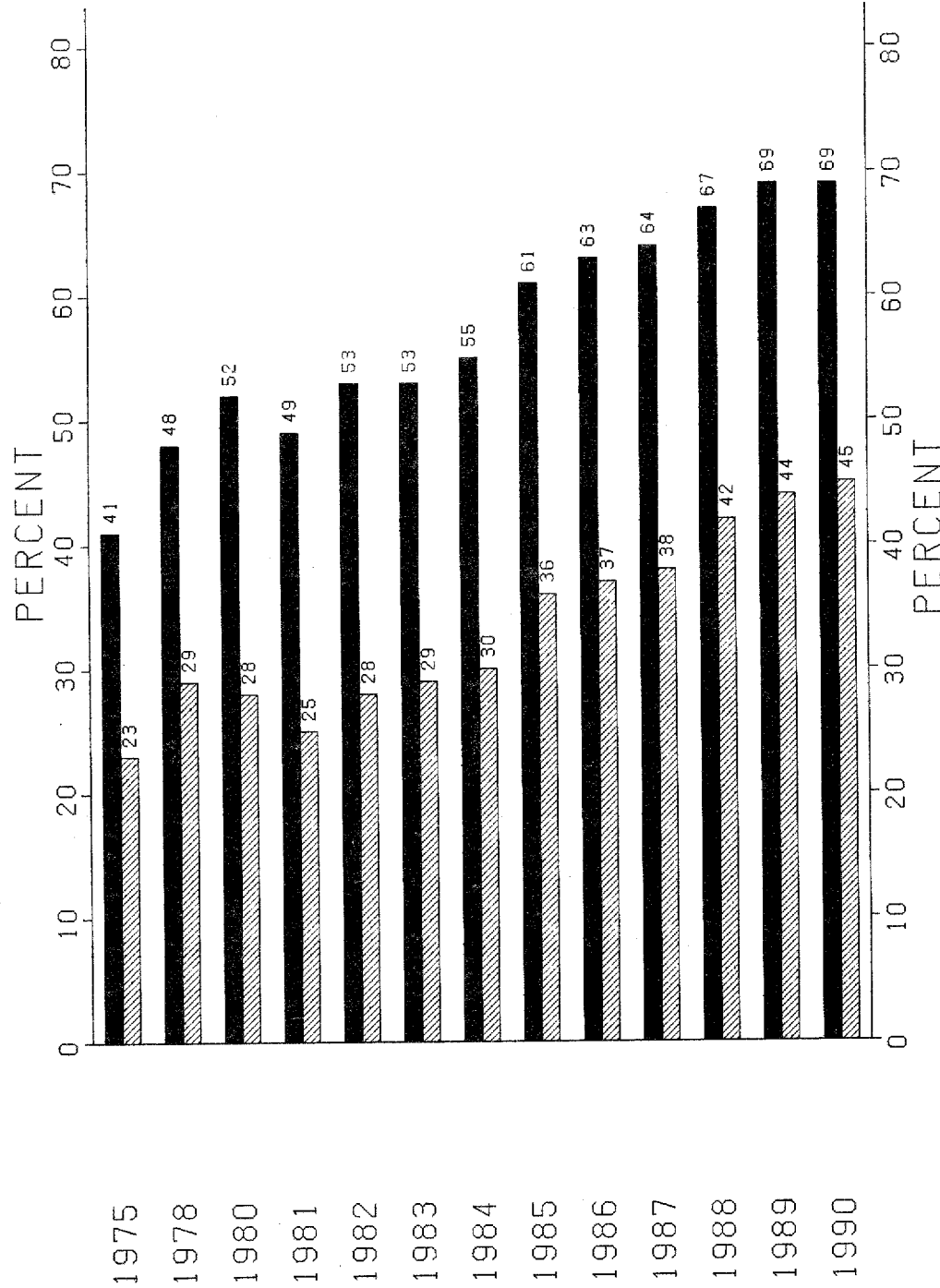

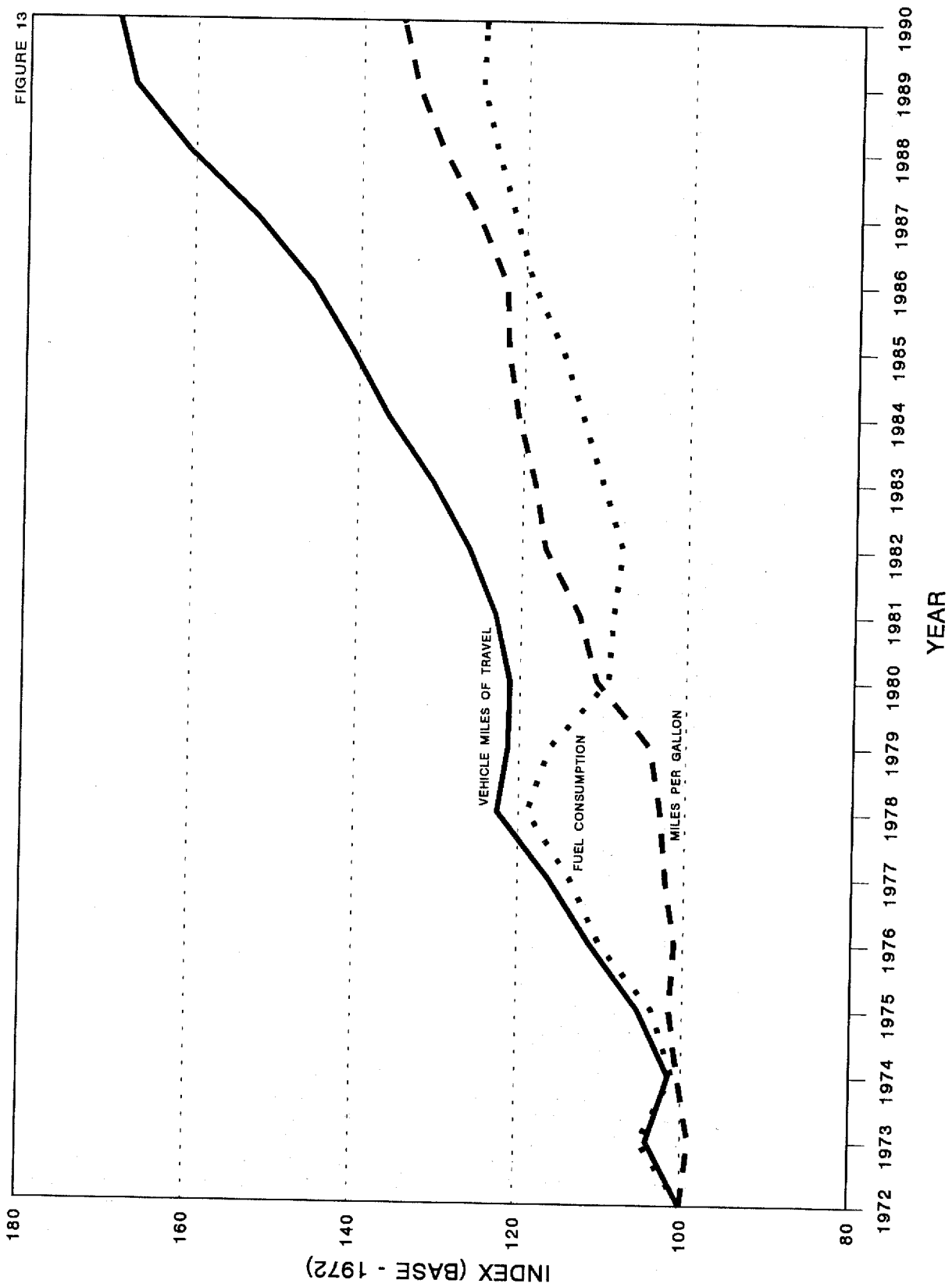

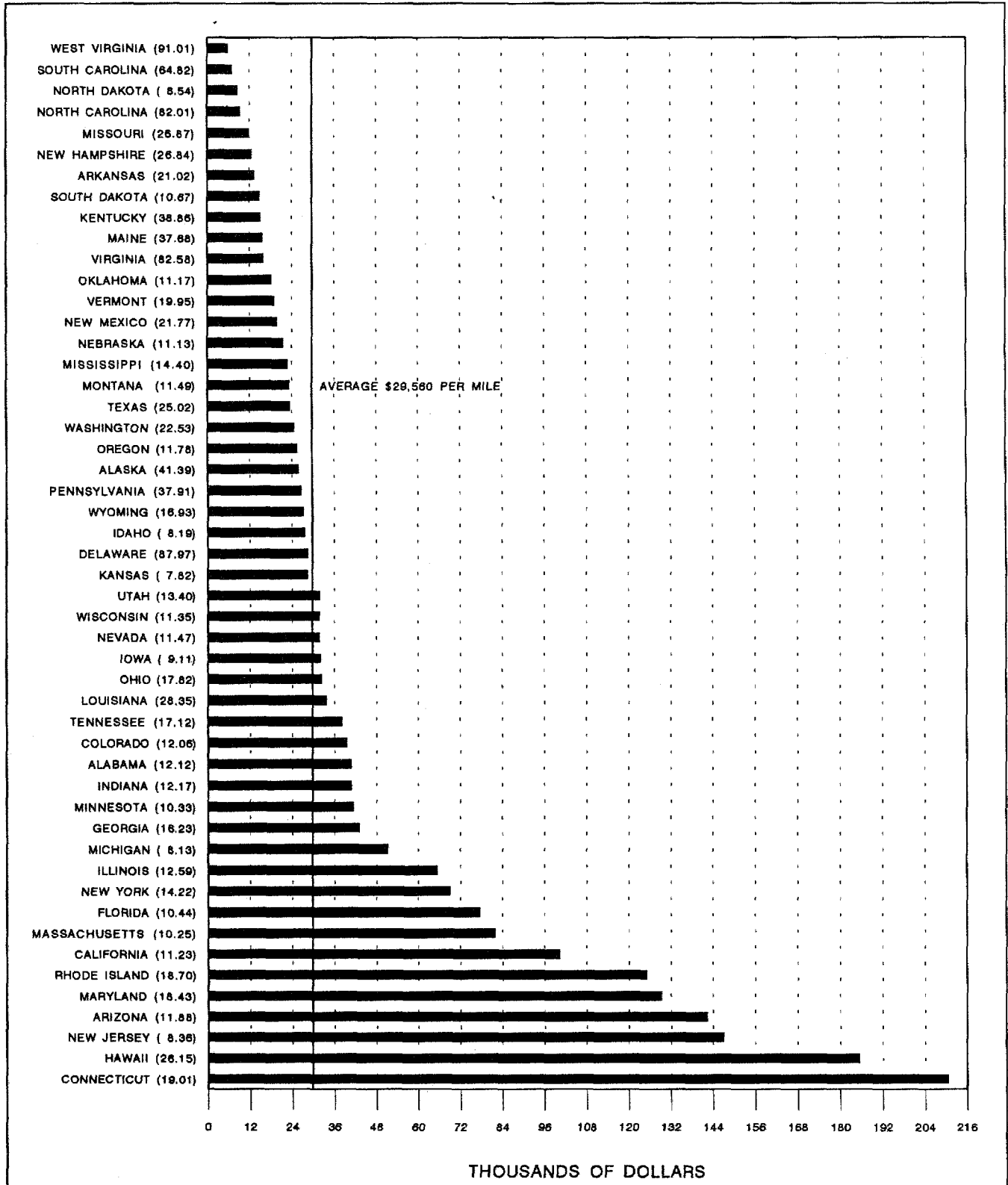

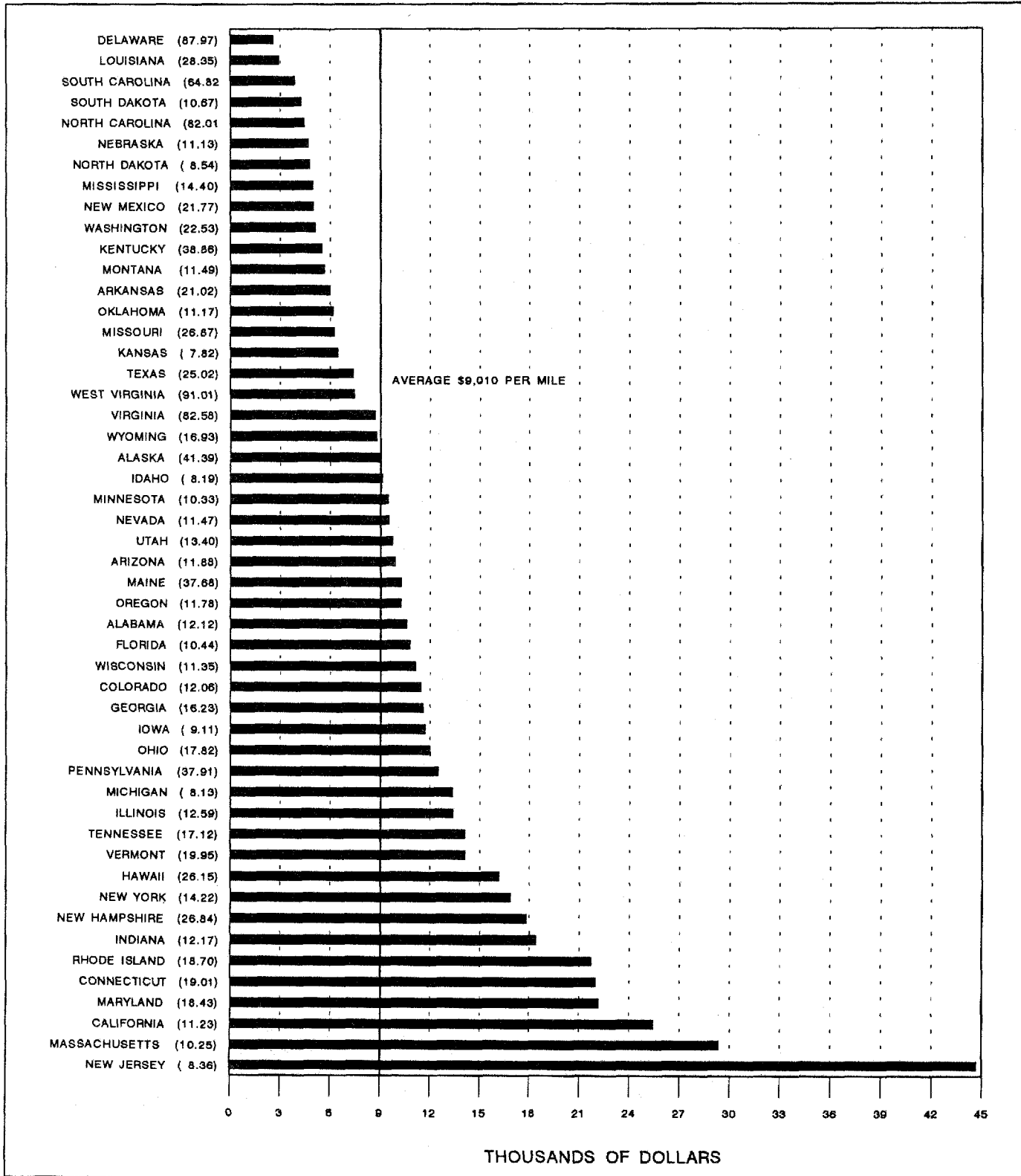

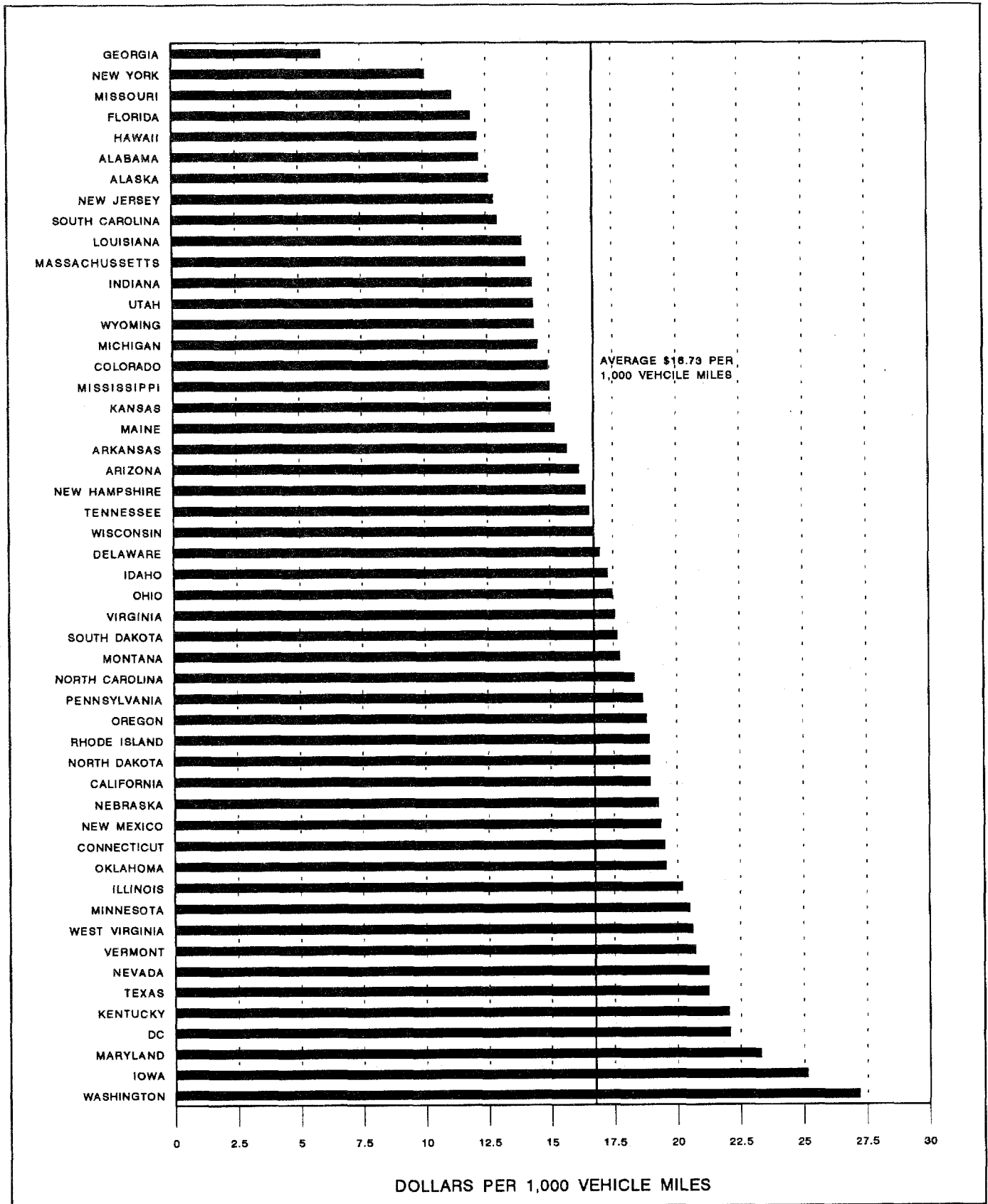

STATE HIGHWAY-USER REVENUE PER VEHICLE MILE OF TRAVEL

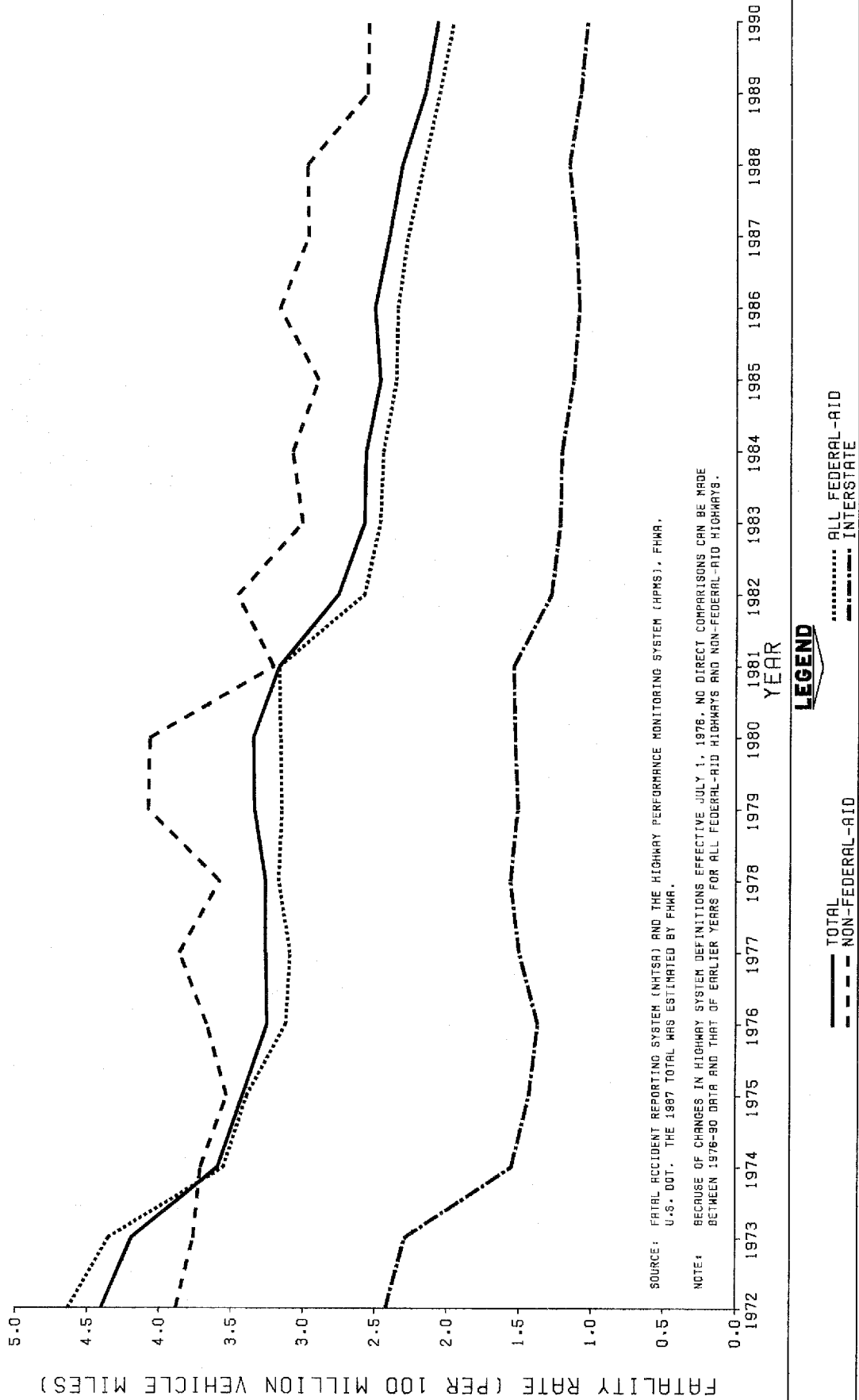

FATALITY RATES FEDERAL-AID AND NON-FEDERAL-AID HIGHWAYS 1972 - 1990

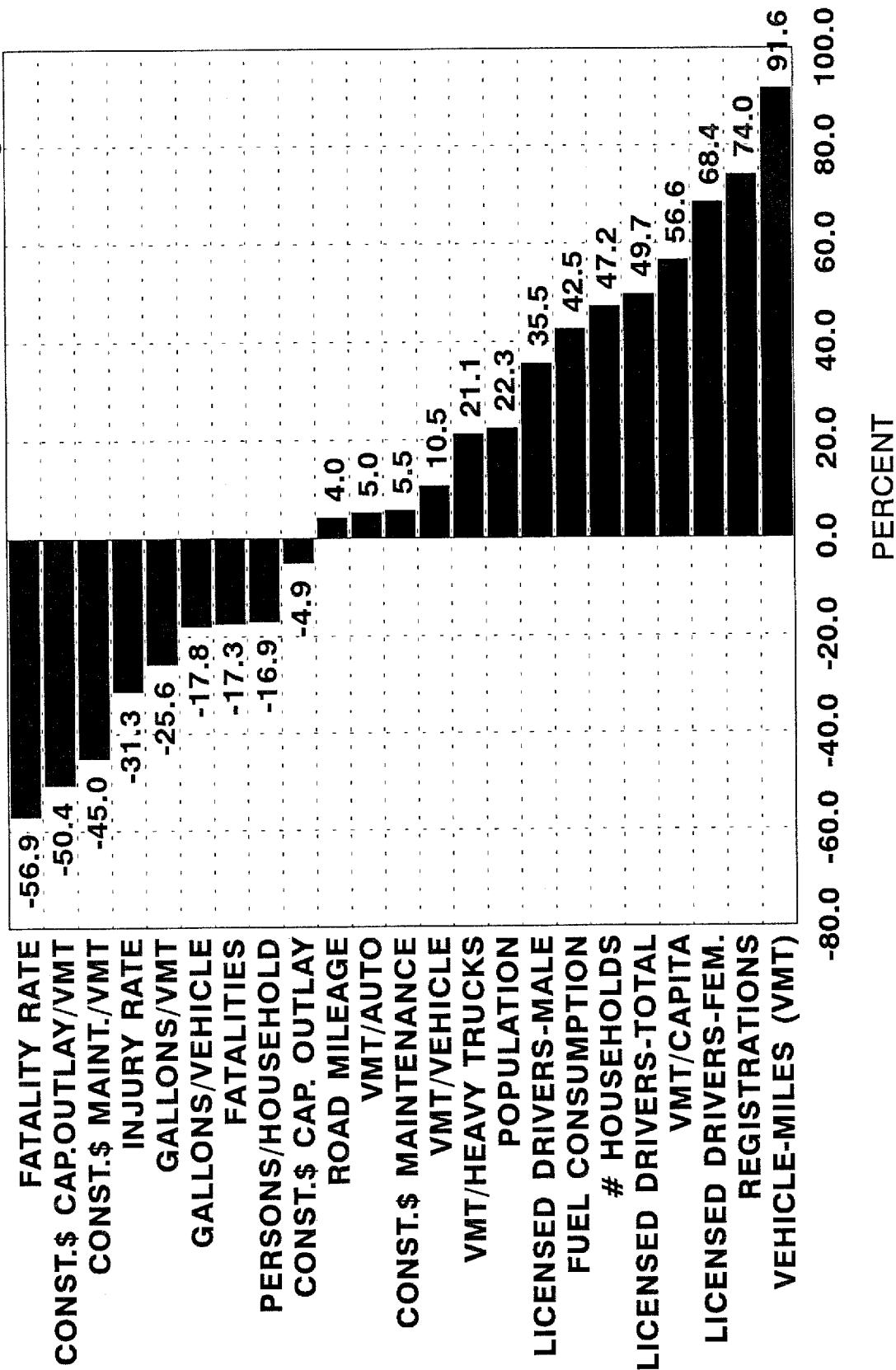
