## Appendix D Definitions

**EMI eLearning**: proprietary FEMA LMS. This LMS was developed internally by FEMA personnel; this system is not SCORM compliant and not able to interpret SCORM API calls. However calls used in conjunction with a standard web-based server (i.e. check browser version, etc) may be used. The "no hooks" version of the course is developed for this LMS.

**FEKC**: FEMA Employee Knowledge Center. This LMS is a Meridian-based system located behind the FEMA firewall and is for use by FEMA employees only. The FEKC is fully SCORM compliant and currently supports SCORM version 1.2; SCORM 2004 will be supported at some point in the future.

**No Hooks**: The "no hooks" version referenced in this SOW refers to the deliverable needed for use with the FEMA EMI eLearning LMS (referenced above). This LMS is linked from the following website: <a href="http://training.fema.gov">http://training.fema.gov</a>; because this LMS has limited functionality and is proprietary in nature, SCORM calls are not recognize by this system, thus, necessitating the need for a "no hooks" version of the course.
