Course Length:

This course is conducted 16 hours, over a two-days.

Location:

Emergency Management Institute Pre-Symposium Workshop Training

Program Description:

The E0146 - HSEEP: Basic course provides a comprehensive overview of exercise design along with practical skill development. Using the same terminology and processes, this course will provide activities that will give participants an opportunity to interact with many of the templates and other materials that are detailed in the HSEEP doctrine created and maintained by the National Exercise Division to ensure exercises are conducted in a consistent manner.

Course Objective:

Upon completion of this course, participants will gain a better understanding of what constitutes an effective exercise.

Course Design:

The classroom version of the HSEEP course follows a traditional classroom format: combines lecture, small-group activities, and a pre- and post-knowledge check to determine how well participants learned during this course. Small-group activities reinforce the concepts taught during lectures.

Prerequisite:

• IS 120.a - An Introduction to Exercises

Recommended Course:

• IS 130 - Exercise Evaluation and Improvement Planning

Attendance:

It is mandatory that the participant complete all 16 hours of this course to receive full credit. Anything less the participant is required to reregister for another course and start from the beginning.
