## **CONSENT ORDER**

This consent order concerns unauthorized air carrier operations by Calypso Airline, Inc. (Calypso) which engaged in air transportation without the requisite economic authority from the Department. It directs Calypso to cease and desist from such future unlawful conduct and assesses the company \$60,000 in compromise civil penalties.

Companies engaged in air transportation are required to hold economic authority from the Department under 49 U.S.C. § 41101.<sup>1</sup> A carrier may also operate small aircraft as an air taxi under the exemption authority of 14 CFR Part 298.<sup>2</sup> Calypso is a charter company that provides air service using its own small aircraft and crew. However, it is not registered as an air taxi under 14 CFR Part 298 and, therefore, does not have the economic authority itself to hold out or to provide air transportation, directly or indirectly.<sup>3</sup> Calypso has nonetheless engaged in air transportation since it began operations in March 2003. Calypso's unlawful operations as an air carrier, in addition to violating the certificate requirements of Title 49, constitute an unfair and deceptive trade practice and an unfair method of competition in violation of 49 U.S.C. § 41712.

Pursuant to 49 U.S.C. §§ 41101 and 41102, citizens of the United States<sup>4</sup> may not engage in air transportation unless they hold a certificate of public convenience and necessity authorizing them to provide air transportation as an air carrier. An "air carrier" means a citizen "undertaking by any means, directly or indirectly, to provide air transportation."<sup>5</sup> "Air transportation" includes the transportation of passengers or property by aircraft as a common carrier for compensation between two places in the United States or between a place in the United States and a place outside of the United States.<sup>6</sup> Common carriage, in the context of air service, consists of the provision or holding out of air transportation to the general public for compensation or hire.<sup>7</sup> From the standpoint of the requirements of 49 U.S.C. § 41101, the holding out of service, as well as the actual operation of air service, constitutes "engaging" in air transportation.<sup>8</sup> Violations of section 41101 also constitute unfair and deceptive practices and unfair methods of competition in violation of 49 U.S.C. § 41712.

Calypso was the lessee of two Cessna 402 aircraft, both of which were placed on the FAA Part 135 operations specifications and DOT air taxi registration of another operator. However, Calypso marketed in its own name air transportation using these aircraft on its Internet web site and in advertisements placed in various periodicals.<sup>9</sup> Moreover, Calypso actually operated the flights that it marketed using its own pilots. Thus, the placement of the aircraft on the licensed air carrier's operating certificate appears to have been one of mere convenience.<sup>10</sup> It is clear that at no time in this matter did Calypso act as an agent of the certificate holder or of any other licensed carrier. Rather, acting deceptively under the imprimatur of another company's certificate, Calypso held out and

engaged in air transportation without appropriate economic authority and thereby also engaged in an unfair and deceptive practice and unfair method of competition in violation of 49 U.S.C. § 41712.

In mitigation, Calypso states that it did not intend to violate the Department's licensing requirements and that, upon being contacted by the Department's Office of Aviation Enforcement and Proceedings (Enforcement Office), it took immediate remedial action. To this end, Calypso retained experienced aviation counsel, who has sought guidance on its behalf from the Enforcement Office to ensure that, in the future, the company does not hold out or engage in air transportation without the appropriate economic and safety authority. Moreover, Calypso points out that at all times in this matter it has cooperated fully with the Enforcement Office.

We view seriously attempts by unauthorized companies to circumvent Departmental licensing requirements by engaging, as Calypso has, in what is, in effect, a "rent-acertificate" arrangement with a duly authorized carrier. We have carefully considered the facts of this case, including the explanation provided by the company, and continue to believe enforcement action is necessary. Calypso, in order to avoid litigation and without admitting or denying the alleged violations, agrees to the issuance of this order to cease and desist from future violations of 49 U.S.C. §§ 41101 and 41712, and to an assessment of \$60,000 in compromise of potential civil penalties. Of this total penalty amount, \$30,000 shall be paid under the terms described below. The remaining \$30,000 shall be suspended for two years following the issuance of this order, and then forgiven, unless Calypso violates this order's cease and desist or payment provisions, in which case the entire unpaid amount shall become due and payable immediately and Calypso may be subject to further enforcement action. This compromise assessment is appropriate in view of the nature and extent of the violations in question and serves the public interest. This settlement, moreover, represents a deterrent to future air transportation operations without appropriate economic authority by Calypso, as well as other similarly situated companies.

This order is issued under the authority contained in 49 CFR 1.57a and 14 CFR 385.15.

## ACCORDINGLY,

1. Based on the above discussion, we approve this settlement and the provisions of the order as being in the public interest;

2. We find that Calypso Airline, Inc., violated 49 U.S.C. § 41101, as described above, by engaging in air transportation as an air carrier without appropriate economic authority;

3. We find that by engaging in the conduct described in paragraph 2, above, Calypso Airline, Inc., engaged in an unfair and deceptive practice and an unfair method of competition in violation of 49 U.S.C. § 41712;

4. Calypso Airline, Inc., and all other entities owned and controlled by, or under common ownership and control with Calypso Airline, Inc., and their successors and

assignees, as well as the owners and officers of all such companies, are ordered to cease and desist from further violations of 49 U.S.C. §§ 41101 and 41712;

5. Calypso Airline, Inc., is assessed \$60,000 in compromise of civil penalties that might otherwise be assessed for the violations described in ordering paragraphs 2 and 3, above. Of this total penalty amount, \$5,000 is due and payable within 30 days of the date of issuance of this order, \$5,000 is due and payable on December 15, 2004, \$5,000 is due and payable on March 15, 2005, \$5,000 is due and payable on June 15, 2005, \$5,000 is due and payable on June 15, 2005, \$5,000 is due and payable on September 15, 2005, and \$5,000 is due and payable on January 15, 2006. The remaining \$30,000 shall be suspended for two years following the date of issuance of this order, and then forgiven, unless Calypso Airline, Inc., violates this order's cease and desist or payment provisions, in which case the entire unpaid amount shall become due and payable immediately and Calypso Airline, Inc., may be subject to further enforcement action. Failure to pay the penalty as ordered shall also subject Calypso Airline, Inc., to the assessment of interest, penalty, and collection charges under the Debt Collection Act and to enforcement action for failure to comply with this order; and

6. Payment shall be made by wire transfer through the Federal Reserve Communications System, commonly known as "Fed Wire," to the account of the U.S. Treasury. The wire transfer shall be executed in accordance with the instructions contained in the Attachment to this order.

This order will become a final order of the Department 10 days after its service date unless a timely petition for review is filed or the Department takes review on its own motion.
