1. Introduction

Discussion of climate change is becoming more common in transportation planning documents. Many state DOTs and MPOs are recognizing the role that transportation policies and investments play in contributing to climate change and conversely, the potential impact of climate change on transportation systems. Long range transportation plans (LRTPs) in particular are highlighting climate change among a new generation of environmental and sustainability issues that shape transportation planning objectives.

At present, there is no federal regulatory requirement for state DOTs and MPOs to consider climate change in transportation plans. As such, agencies that are working on climate change are creating their own models for integrating climate change into their transportation plans. These models are reflected in the language that agencies use about climate change in their planning documents. Many agencies provide a robust explanation of why climate change is a transportation planning issue, context about latest developments in climate change policy, and establish new policies related to climate change.

This document provides excerpts from MPOs' and DOTs' transportation plans that discuss climate change. It is intended to guide other agencies in discussing climate change in their own plans. Although some general discussions of climate change are applicable to plans in any state or region, most of the language in existing plans is specific to the particular policy and planning context. Nonetheless, agencies that are looking for ideas about how to incorporate climate change in their transportation plans will find helpful models here.

Transportation Improvement Programs (TIPs) can also consider climate change, in a different context than transportation plans. TIPs are not policy documents, but rather lists of projects selected for funding. Any discussion of climate change occurs in the LRTP. But TIPs can incorporate climate change to the extent that climate change is a consideration in selecting projects. No MPOs or DOTs have yet explicitly incorporated climate change in their TIPs, but we offer some suggestions for how they might.

2. Model Language in State and Regional Transportation Plans

In this section, quotes from various transportation plans illustrate how agencies have incorporated climate change impacts into their plans. These can be helpful as more agencies consider how climate change will affect the transportation sector and how to include those considerations in their transportation plans. These model statements are just some examples of the variety of ways that agencies try to address the issue of climate change and transportation.

Transportation plans are unique to each planning agency. Mention of climate change and greenhouse gases can appear throughout long range transportation plans to various degrees. Generally, MPOs and DOTs address a few broad questions in discussing climate change in their plans. Text excerpts are organized according to these questions:

- What is climate change?
- How does transportation contribute to climate change?

- How does climate change affect transportation?
- Why should transportation plans address climate change?
- How does the plan address climate change?
- What existing policies and programs on climate change are relevant to the plan?
- What steps should transportation agencies take to address climate change?

2.1. What is climate change?

- “The earth’s atmosphere is warmed resulting in climate change and potential adverse impacts to public health, agriculture, forests, storm frequency and intensity, mountain snow pack, smog, and rising sea levels.”

- “Global climate change caused by greenhouse gases produced from fossil fuel use;”

- “CO₂ is a greenhouse gas (GHG) that traps heat in the atmosphere and is a significant contributor to global climate change. Some climatic changes in California have been recorded that suggest important risks lie ahead for the State’s agriculture, energy, and transportation sectors.”

- “According to the FHWA report Integrating Climate Change into the Transportation Planning Process, there is general scientific consensus that the earth is experiencing a long-term warming trend and that human-induced increases in atmospheric greenhouse gases (GHGs) may be the predominant cause.”

- Climate Change definition:

(See also Global Warming.)”

2.2. How does transportation contribute to climate change?

- “The transportation sector’s adverse contribution to climate change is primarily through greenhouse gas emissions from cars, trucks, buses, trains and ferries.”

- “The consumption of fossil fuels such as gasoline, diesel and natural gas by motor vehicles has been shown by scientists to lead directly to climate change.

The challenge here is different than it is to control air pollution: carbon dioxide (along with water) is the natural end product of the clean burning of petroleum fuels, so the only way to reduce the influence of global climate is to reduce the amount of fuel burned, or to find a new fuel for vehicles that does not come from oil. Even carbon emissions from ‘cleaner’ sources such as natural gas, ethanol, or electricity (unless derived from solar, wind, or nuclear energy) play a role in climate change.

To reduce the negative effects of fossil fuel consumption and climate change, two themes emerge.

- ◆ First, technology changes (cleaner engines, better gas mileage and alternative fuels) have the potential to slow the effects of climate change. In addition, higher prices will regulate fuel consumption. However, there is a worry that the shift to more energy-efficient vehicles will occur too slowly to avoid potentially significant crises that will challenge the transportation system.
- ◆ This leads to the second theme: changing travel behavior. If people shift to greater use of alternative modes (transit, bicycling and walking), as discussed in Chapter 11, the effects on the environment and the reliance on oil is reduced, and people will have choices if the price of fuel rises too high.”

- “How much can we rely on technology—clean-burning engines and fuel efficiency—to achieve objectives for air quality and global climate change, and how much on the reduction of vehicle trips?

- ◆ The only technology improvements that can be effective against climate change would have to increase fuel efficiency significantly, allow use of non-carbon fuels, or perhaps capture the carbon dioxide that goes out the exhaust pipe (an approach that offers far more promise for factory smokestacks than on-board vehicles).

How can we reduce fossil fuel consumption and slow down climate change?

- ◆ Climate change and fuel consumption are among the most vexing issues facing the region, as to where fuel conservation could be most effective and what to do to move in that direction.”

The United States is the largest energy user in the world and emits almost one-quarter of the world’s greenhouse gases, primarily carbon dioxide. Greenhouse gases contribute to warming the climate. Transportation activities are estimated to be the second largest single source of greenhouse gas emissions and are responsible for 38 percent of Oregon’s carbon dioxide emissions. The Oregon Department of Energy predicts that carbon dioxide emissions in the state will increase by 33 percent from 2000 to 2025 mainly because of increased driving.”

- “Global climate change threatens ecosystems around the planet, and our economy continues to be highly dependent on an uncertain future supply of petroleum. While no single solution will be capable of meeting the challenges of these twin crises, a series of partial solutions implemented together can achieve sustainability. The Recentralization scenario, by reducing energy demand and CO2 emissions, can be a key part of this solution.”

Public education regarding the effects of auto-dependant land use and development patterns that require excessive commuting or other auto travel may also contribute to greater recognition, over time, of the connection between individual lifestyle choices and air pollution. As fuel prices reach an all time high, the need to reduce our reliance on foreign oil and turn to renewable sources and conservation measures has never been greater.”

Burning conventional diesel and gasoline in our motor vehicles and equipment is responsible for the bulk of our greenhouse gases and other air toxics. Choosing cleaner alternatives and retrofitting older machinery to be less-polluting are affordable ways to protect our air.”

2.3. How does climate change affect transportation?

- “Climate change is expected to significantly affect the Bay Area’s transportation infrastructure through sea level rise and extreme weather.”

- “Connecticut’s greenhouse gas (GHG) emissions from non-renewable fuel consumption are contributing to the global climate change. The impacts of climate change on Connecticut may eventually affect our transportation infrastructure; impacts may include sea level rise, increases in the extent and frequency of coastal flooding, shoreline erosion and retreat, and increased likelihood and severity of damaging rainstorms.”

- “Two impacts of global warming on transportation facilities in the Pacific Northwest are rising sea levels and increased wave heights. Both could have severe impacts on Highway 101, coastal ports and other coastal transportation facilities.”

- “Potential impacts of climate change upon our region’s transportation system include changes in the safety, operations, and maintenance of the region’s transportation infrastructure and systems. The H-GAC region is particularly vulnerable to hurricanes/tropical storms and flooding, which may be intensified by sea level rise and/or land subsidence.

H-GAC, in coordination with the Department of Transportation and other entities are working to identify the potential impacts of climate change and variability on our region’s transportation system and ultimately to develop strategies and policy options to adapt to any future changes. Due in December 2007, the U.S. Department of Transportation study “The Impacts of Climate Change and Variability on Transportation Systems and Infrastructure: Gulf Coast Study” will be particularly beneficial in assisting H-GAC’s transportation and climate change planning efforts.”

- “In addition to reducing the impacts from the transportation sector on climate change, it is also important for the region to address the impacts from climate change. This concept is referred to as ‘adaptation to climate change.’ Beyond transportation, a wide variety of impacts from long term climate change may be expected in Washington state and the Puget Sound region. These include rising sea levels, increased flooding, and an increase in the frequency and severity of storms and other weather events, droughts, wildfires, impacts to water availability and quality, and impacts to crops. Specific to transportation, impacts could include the accelerated deterioration of roadways, issues related to flooding and increased stormwater, bridge damage, rail buckling, and reduced water levels in some water bodies that could affect the passage of ships and barges.”

2.4. Why should transportation plans address climate change?

- “Because the consequences of climate change are serious, the Bay Area needs to take aggressive action to reduce its transportation-related emissions, setting the example for the rest of California and for the national and international community. We will have to consider these consequences throughout our transportation and land-use planning; and we will need to ensure climate resilience in our infrastructure and development choices...”

- “Our vision for the future advances the ideals of our people, our prosperity, and our planet. As we work toward achieving the region’s vision, we must protect the environment, support and create vibrant, livable, and healthy communities, offer economic opportunities for all, provide safe and efficient mobility, and use our resources wisely and efficiently. Land use,

economic, and transportation decisions will be integrated in a manner that supports a healthy environment, addresses global climate change, achieves social equity, and is attentive to the needs of future generations.”

- “VISION 2040 envisions a future where... Meaningful steps are taken to reduce carbon emissions and minimize the region’s contribution to climate change.”

- “However, the automobile and suburban house will not be the only option. In a world of increasing scarcity, growing concern about climate change, intense global competition, and an aging population, provision of mixed-use, transit-oriented communities are critical for reducing CO2 emissions, attracting skilled workers, and providing for quality of life.”

This includes efforts to maximize energy efficiency and increase renewable energy, reduce greenhouse gas emissions of new vehicles, reduce motor vehicle miles traveled, improve the convenience and safety of nonpolluting transportation modes such as bicycling and walking, protect the natural landscape and vegetation, and increase recycling and reduce waste.”

2.5. How does the plan address climate change?

- “Climate-Friendly Investments Dominate Spending.

The overwhelming share of plan expenditures — 97 percent — goes to support maintenance and operations, transit expansion, and bicycle and pedestrian improvements. These directly support the regional effort to respond responsibly to climate change. Many of the discrete investments in the plan are climate-friendly and aim to reduce greenhouse gas emissions from transportation sources.”

- “To deal with the much larger issue of global warming, MaineDOT is engaged in many activities and programs, and anticipates that these efforts will need to be increased as the issue becomes more defined. Ambitious initiatives such as the Maine Climate Action Plan’s goal to reduce greenhouse gas emissions to 1990 levels by 2010, and to 10% below those levels in 2020 will challenge MaineDOT’s long-range delivery of transportation improvements. The transportation sector represents the largest source of greenhouse gas (GHG) emissions in Maine at about 28% of total GHG emissions. Under a business-as-usual scenario, GHG emissions will increase 48% from 1990 levels by 2020. By implementing long-range transportation actions such as slowing VMT growth, utilizing low-GHG fuel, and implementing tailpipe emission standards, GHG emissions from 2010 to 2020 can be decreased by 28.8%. Long-range strategies will need to increase the availability of low-GHG travel choices, such as transit, vanpools, walking, and biking. Complementary policies will need to address land use and location efficiency, and create transit-based incentives, to improve the attractiveness of these low-GHG travel choices.”

“MaineDOT estimates that the strategic investments in the highway and transit projects identified in his Plan will reduce emissions of CO₂ by 26 to 32 thousand metric tons by 2020, and 40 to 48 metric tons by 2030.”

SCAG’s vision includes the introduction of a high-speed, high-performance regional transport system that may potentially reduce airport and freeway congestion and provide an alternative to the single-occupancy automobile. In order to disclose potential environmental effects of the RTP, SCAG has prepared an estimated inventory of the region’s existing GHG emissions, identified mitigation measures, and compared alternatives in the PEIR. The mitigation measures seek to achieve the maximum feasible and cost-effective reductions in emissions. There are difficulties in quantifying reductions in GHG emissions due to insufficient data.”

- “An issue garnering significant attention is climate change related to greenhouse gases. While there are no established Federal standards for greenhouse gases, and Outlook 2035 does not directly address the issue of climate change, Outlook 2035’s overall goals for reducing vehicle emissions should have a positive effect on the Baltimore region’s inventory of greenhouse-house gases.”

- “However, the Connections Plan also introduces several new elements to the long-range planning process, such as climate change and energy initiatives, local food production, and cultural and historic landscapes, which heighten the linkages between land use, the environment, the region’s economic competitiveness, and the transportation network.”

- “Water is of critical importance to sustain the natural environment and meet the region’s growth needs. To those ends, VISION 2040 calls for maintaining and restoring the ecological functions of the region’s waterways and estuaries. It calls for reducing water pollution and taking steps to address the impacts of climate change on the region’s water quality and supply.”

Puget Sound Regional Council (PSRC), Seattle, Washington. Vision 2040, adopted Spring 2008, page 39: Multicounty Planning Policies.

- “A key focus of the plan will be to protect and improve the region’s environmental health. This will include ensuring that the region has healthy air that meets all standards; ensuring that transportation projects improve the handling of stormwater runoff to protect Puget Sound and other surface waters; and address emerging issues such as transportation’s role in reducing greenhouse gas emissions and adapting to climate change. The plan includes a specific strategy to address state GHG goals, and vehicle miles traveled (VMT) reduction benchmarks. The four-part strategy includes Land Use, Transportation Pricing, Transportation Choices, and Technology. In addition, the Plan builds on current efforts to protect natural areas and support vibrant, livable communities.”

- “The plan is designed to keep the region’s air and water healthy, sustain the region’s overall ecology, assist in coordinated efforts of the Puget Sound Partnership to protect and restore the health of the region’s watersheds, and lead in the development of emerging federal and state initiatives to reduce overall greenhouse gas emissions to address global climate change.”

- “VISION 2040 calls for the region to reduce its overall production of harmful elements that contribute to climate change, and commits the region to comply with state directives. An evaluation of greenhouse gas emissions and vehicle miles traveled per capita was conducted in the process to develop Transportation 2040. The results of this analysis and additional research produced a four-part greenhouse gas strategy as a central part of Transportation 2040.”

- “From the start, we extended our reach and embraced a new partnership with our sister regional agencies — the Association of Bay Area Governments, the Bay Area Air Quality Management District, and the Bay Conservation and Development Commission — to help us develop this long-range plan. With the help of our regional partners, this plan no longer focuses solely on surface transportation infrastructure but takes into account how transportation affects our land-use patterns, air quality and climate changes, and vice versa.”

- “Our transportation decisions and actions can either help or hinder efforts to protect the climate, and to this end, the Commission has set aside \$400 million to implement a Transportation Climate Action Campaign that focuses on individual actions, public-private partnerships, and incentives and grants for innovative climate strategies. Known for its commitment to the environment, the Bay Area is ideally suited to provide regional leadership and serve as a model for California, the nation and the world in our efforts to reduce our carbon footprint. This plan advances the fight against global warming and validates the region’s reputation as a forward-looking force for change.”

- “This plan does not include a quantitative assessment of Greenhouse Gases. However, as more consistent methods to measure GHG emissions are developed, and as legislative and regulatory mandates emerge (i.e., SAFETEA-LU reauthorization), MUMPO will address

them accordingly. In the meantime, MUMPO will work on providing more education about transportation and its effects on climate change.”

Mecklenburg-Union MPO (MUMPO), North Carolina. Draft 2035 LRTP, February 2010, page 8-10: Environment.

- “Preliminary scenarios modeling conducted in 2008 looked at how vehicle emissions might change over time with different investment choices to illustrate the region’s ability to continue to meet current state and federal air quality requirements and state targets to reduce greenhouse gas emissions. None of the scenarios, including the reference scenario, achieve the state targets by 2035. The region’s growing population will make it difficult to achieve the targets without other strategies. The region must identify the land use and transportation strategies needed to meet them. The region will also need to support new technology and conservation measures. The scenarios work in 2010 will evaluate a full array of land use and transportation strategies.”

- The 2035 RTP represents the first steps in H-GAC’s integration of climate change into the transportation planning process. An additional step in linking transportation and climate change to the transportation planning process will be an increased recognition of the contributions of the transportation system to GHG emissions and potential strategies to reduce, mitigate and eliminate these emissions. H-GAC currently has an extensive Clean Air Initiatives program and future efforts may create linkages to other H-GAC programs and initiatives.”

2.6. What existing policies and programs on climate change are relevant to the plan?

In 2004, Connecticut became the first state to develop a comprehensive climate change action plan and immediately translate it into legislative and administrative proposals for implementation.”

The Executive Order also establishes a Climate Action Council that is charged with preparing a draft Climate Action Plan by September 30, 2010. The Climate Action Plan will identify possible strategies for meeting the 80 by 50 goal.”

- ◆ Tax reductions for manufacturers of solar energy systems and components.
- ◆ A requirement that buildings belonging to Washington State and all buildings receiving state construction funding receive “green building” certification.
- ◆ A tax rebate for individuals and businesses that generate energy from wind, solar power, or biodigesters.
- ◆ A requirement that most diesel fuel sold in Washington State contain at least two percent biodiesel. Also, gasoline must contain at least two percent ethanol.
- ◆ A requirement that state agencies, including the Washington State Department of Transportation, increase biodiesel usage to 20 percent by June 1, 2009. This will create a better market for agricultural production of fuel oils while reducing diesel toxics and greenhouse gas emissions.
- ◆ The Energy Freedom Program will provide low interest loans for biodiesel processing and infrastructure development in order to produce sufficient quantities of biofuels in Washington State to meet the requirements and the growing demand.”

3. Climate Change in Transportation Improvement Programs

Projects in Transportation Improvement Programs (TIPs) can be selected for their potential to help reduce transportation GHG emissions or make transportation systems more resilient to the impacts of climate change. To this extent, TIPs can also consider climate change. To our knowledge, no MPOs or DOTs have formally used GHG emissions or resilience to climate change as selection criteria for projects in TIPs.

Some MPOs are experimenting with the use of GHG emissions as a measure for evaluating projects or packages of projects in the decision-making process. San Francisco’s Metropolitan Transportation Commission (MTC) used GHG emissions as a performance measure to rank and evaluate some projects in the development of its most recent LRTP. Packages of projects were also evaluated using the GHG emissions criterion. The Puget Sound Regional Council (PSRC) included GHG emissions in its evaluation of packages of projects selected in its LRTP. The use of these criteria will have a second-order effect on those projects selected for TIPs. Other agencies have considered using GHG emissions impacts as an evaluation factor for grant programs such as the Congestion Management and Air Quality Improvement (CMAQ) program.

As the use of explicit performance measures for transportation project selection expands, MPOs and DOTs will have more opportunities to incorporate climate change in the selection process for projects in TIPs. At the federal level, the new HUD-DOT-EPA Interagency Partnership for Sustainable Communities is promoting the use of performance measures in transportation decisionmaking. In California, MPOs are asked to explain the performance of their proposed TIPs relative to a specific list of performance measures.¹ Although GHG emissions are not

included in the list, the inclusion of some performance measure related to climate change is a logical future policy step.

For the most part, TIPs are lists of projects with little accompanying text. What text does appear in the TIP document is typically an explanation of federal and state regulations that drive the development of TIPs. Currently climate change does not factor into those regulations. Since TIPs do not develop and set policies for transportation decisionmaking, there is little room for discussion of climate change in the documents. If and when criteria related to climate change are used to specifically to select projects for TIPs, a limited discussion of climate change in the context of the criteria can be expected.

Substantive discussions of climate change are logically confined to the LRTP. The LRTP provides a venue for description of scientific and planning issues related to climate change, and development of policies related to reduction of GHG emissions and protection of the transportation system from the impacts of climate change.
