





4 - 极易燃; 3 - 常温下可点燃;
 2 - 适度加热时可点燃; 1 - 必须预热才能燃烧;
 0 - 不会燃烧




4 - 进入蒸气或液体非常危险;
 3 - 极其危险 使用全身防护服
 2 - 危险 - 使用呼吸器
 1 - 轻微危险
 0 - 像普通材料一样

红色 - 易燃

4 - Extremely Flammable; 3 - Ignites at normal temperatures;
 2 - Ignites when moderately heated; 1 - Must be preheated to burn;
 0 - Will not burn

蓝色 - 健康

4 - Too dangerous To enter vapor or liquid;
 3 - Extremely dangerous Use full protective clothing
 2 - Hazardous - Use breathing apparatus
 1 - Slightly hazardous
 0 - Like ordinary material



黄色 - 反应性

4 - May detonate - vacate area if materials are exposed to fire
 3 - Strong shock or heat may detonate - use monitors from behind explosive Barriers
 2 - Violent chemical change possible - use hose streams from a distance
 1 - Unstable if heated - use normal precautions
 0 - Normally stable

4 - 可能引爆 - 如果材料暴露于火源则撤离该区域
 3 - 强烈冲击或热量可能引爆 - 从炸药阻挡层后面使用监视器
 2 - 可能出现剧烈化学变化 - 从远处用软管浇水
 1 - 如果加热则不稳定 - 采用常规预防措施
 0 - 正常情况下稳定

- 在奥克兰港使用类似制度。长滩港审查适应类似格式的选项。
- 洛杉矶港警方危险品单位和洛杉矶消防临港工业单位审查并同时批准许可。
- 每年允许25,000人次访问网上货物信息
- 港口警察抽查





根据国土安全部和美国海岸警卫队强制检验特殊货物：

（美国海岸警卫队 联合检验某些危险化学品

- 1.1或1.2部分（炸药）材料，如49 CFR 173.50定义
- 需要根据49 CFR 176.415进行许可的氧化物质或爆破剂
- 高速公路线路控制的放射性物质数量，如在49 CFR 173.403(1) 或III类裂变运送放射性材料，如49 CFR 173.455(a)(3)中所定义
- 散装运输时46 CFR第153部分表1中的每件货物
- 散装运送时以下各项：乙醛、氨（无水）、丁烷、氯、乙烷、乙烯、环氧乙烷、甲烷、磷、丙烷、二氧化硫
- 在POLA的例子 - 军用级炸药、采矿炸药、ANFO、工业放射同位素
