

The SMS provides an assessment of a motor carrier's on-road performance and investigation results within the Behavior Analysis and Safety Improvement Categories (BASICs). Assessments cover 24 months of activity and results are updated monthly. For current Motor Carrier Safety Ratings visit <u>SAFER</u> and for current operating authority and insurance information visit <u>Licensing and Insurance</u> (L&I) system.
