I. Legislative Language

This document has been prepared in response to language in the Joint Explanatory Statement accompanying the *Fiscal Year* (FY) 2016 Department of Homeland Security (DHS) Appropriations Act (P.L. 114-113).

The Joint Explanatory Statement states:

Weapons and Ammunition

The Department shall adhere to statutory weapons and ammunition reporting requirements made permanent in Public Laws 113-76 and 114-4.

P. L. 113-76 states:

- SEC. 569. (a) The Secretary of Homeland Security shall submit to Congress, 180 days after the date of enactment of this Act and annually thereafter beginning with the submission of the President's budget proposal for fiscal year 2016 pursuant to section 1105(a) of title 31, United States Code, a comprehensive report on the purchase and usage of ammunition, subdivided by ammunition type. The report shall include:
 - (1) the quantity of ammunition in inventory at the end of the preceding calendar year, and the amount of ammunition expended and purchased, subdivided by ammunition type, during the year for each relevant component or agency in the Department of Homeland Security;
 - (2) a description of how such quantity, usage, and purchase aligns to each component or agency's mission requirements for certification, qualification, training, and operations; and
 - (3) details on all contracting practices applied by the Department of Homeland Security, including comparative details regarding other contracting options with respect to cost and availability.
- (b) The reports required by subsection (a) shall be submitted in an appropriate format in order to ensure the safety of law enforcement personnel.

II. Overview

DHS has one of the leading federal weapons and ammunition strategic sourcing programs, resulting in significant savings for the American taxpayer. DHS established the Weapons and Ammunition Commodity Council as a cross-component team of subject matter experts to collaborate on DHS weapons and ammunition requirements, and to ensure that weapons and ammunition are available to meet both the DHS mission and its training needs. When practicable, the Commodity Council utilizes strategic sourcing for DHS-wide requirements as a means to procure ammunition at the least possible cost to the taxpayer, and to reduce redundant purchases across the Department. DHS will continue to manage DHS-wide ammunition purchases though the Weapons and Ammunition Commodity Council, which has resulted in savings and other efficiencies exceeding \$13 million more than standard law enforcement pricing. The Weapons and Ammunition Commodity Council will serve as the DHS clearinghouse in which all future ammunition purchases, both DHS-wide and Component-specific, are coordinated to improve visibility across the Department, while ensuring that DHS leverages its spending to the maximum extent practicable. Components will continue to make separate purchases for unique ammunition requirements, but only after first coordinating that purchase through the Weapons and Ammunition Commodity Council. Finally, in support of this congressional reporting requirement, the Commodity Council leadership is working with the DHS Components to expand the use of automated sensitive property accountability systems such as the Firearms, Armor, and Credentials Tracking System to improve the tracking and reporting of sensitive assets.

III. Alignment to Mission Requirements

U.S. Customs and Border Protection (CBP)

CBP is one of the world's largest law enforcement organizations and is charged with keeping terrorists and their weapons out of the United States while facilitating lawful international travel and trade. As the world's first full-service border entity, CBP takes a comprehensive approach to border management and control, combining customs, immigration, border security, and agricultural protection into one coordinated and supportive activity. CBP is divided into three principal operating components: Office of Border Patrol, Office of Field Operations, and Office of Air and Marine. The ammunition-related activity identified in this report was necessary to supply ammunition to a workforce of 45,000 armed law enforcement personnel who are required to demonstrate proficiency with multiple firearms each quarter, and to maintain a constant state of operational readiness.

Federal Emergency Management Agency (FEMA)

The Center for Domestic Preparedness is a DHS/FEMA federal training center that specializes in providing advanced and hands-on training to America's state, local, tribal, parish, federal, private-sector, and international emergency responders to prevent, deter, respond to, and recover from terrorist acts, especially those involving weapons of mass destruction or hazardous materials. The Center has an annual budget of approximately \$65 million primarily devoted to its training mission. The majority of ammunition-related activity in this report was tied to the Center for Domestic Preparedness' need to supply ammunition to more than 55 armed security contractor personnel who are required to demonstrate proficiency with handguns and shotguns and to maintain a constant state of operational readiness in protecting the Center's personnel, property, and unique toxic chemical agency surety program. The armed security services contractor supplies this ammunition as part of its firm, fixed-price contract.

Federal Law Enforcement Training Center (FLETC)

FLETC's mission is to train those who protect our homeland. FLETC serves as an interagency law enforcement training organization for more than 90 federal partner organizations. FLETC also provides training to state, local, tribal, and international law enforcement agencies. During FY 2015, more than 65,000 students received FLETC training. Since it was established in 1970, approximately 1 million law enforcement officers and agents have been trained at FLETC.

U.S. Immigration and Customs Enforcement (ICE)

ICE's primary mission is to promote homeland security and public safety through the criminal and civil enforcement of federal laws governing border control, customs, trade,

and immigration. ICE has an annual budget of more than \$5.9 billion, primarily devoted to its two principal operating components: Homeland Security Investigations and Enforcement and Removal Operations. The ammunition-related activity identified in this report was necessary to supply ammunition to a workforce of 13,000 armed law enforcement personnel who are required to demonstrate proficiency with multiple firearms each quarter, and to maintain constant state of operational readiness.

National Protection and Programs Directorate (NPPD)/Federal Protective Service (FPS)

NPPD/FPS protects federal facilities and those who occupy them by conducting law enforcement and protective security services, and by leveraging access to the intelligence and information resources of its network of federal, state, local, tribal, territorial, and private-sector partners. From its protective security and law enforcement personnel to those who support the operations of FPS, NPPD/FPS approaches its mission as one team. Every day NPPD/FPS protects the homeland by managing risk and ensuring continuity for one of the most crucial elements of our national critical infrastructure: our Nation's federal facilities. NPPD/FPS has an annual budget of more than \$1.3 billion, primarily devoted to its two principal components: Law Enforcement/Security Operations and the Protective Security Officer program. The ammunition-related activity identified in this report was necessary to supply ammunition to a workforce of 1,007 armed law enforcement personnel who are required to demonstrate proficiency with multiple firearms each quarter, and to maintain a constant state of operational readiness.

Office of the Chief Security Officer (OCSO)

OCSO, led by the Chief Security Officer, supports the Management Directorate by providing supervision, oversight, and direction of the DHS security program for personnel, information technology and communications systems, facilities, property, equipment, information, and other material resources. The Chief Security Officer establishes unified policies and business practices across the Department to ensure the efficient and effective use of resources in performing the actions needed to achieve functional excellence in the Security Program. Additionally, pursuant to the Secretary's authority, the DHS Chief Security Officer has designated officers and agents under Title 40, United States Code (U.S.C.), Section 1315(b), for law enforcement duties in connection with the protection of property owned or occupied by the Federal Government and persons on the property, including duty in areas outside the property to the extent necessary to protect the property and persons on the property.

Office of Inspector General (OIG)

OIG's mission is to conduct independent and objective inspections, audits, and investigations to provide oversight and promote excellence, integrity, and accountability in DHS programs and operations. The OIG Office of Investigations investigates allegations of criminal, civil, and administrative misconduct involving DHS employees,

contractors, grantees, and programs. OIG has approximately 200 special agents who are authorized to carry firearms in furtherance of their duties and the OIG mission. These special agents are required to maintain and demonstrate a level of proficiency with issued handguns, shotguns, and rifles. The weapons that the OIG uses that are listed in this report are necessary to equip and maintain its armed workforce.

Transportation Security Administration (TSA)

The mission of the TSA Office of Law Enforcement/Federal Air Marshal Service is to promote public confidence in the security of our Nation's transportation domain. To achieve this mission, TSA deploys federal air marshals on U.S. aircraft worldwide; conducts protection, response, detection, and assessment activities in airports and other transportation systems; maintains TSA's state of preparedness and coordinates incident management; trains and manages all armed pilots; and coordinates all TSA canine assets.

The Federal Air Marshal Service has an annual budget of more than \$800 million. The ammunition-related activity identified in this report was necessary to supply ammunition to armed airline personnel who are part of the Federal Flight Deck Officer Program and armed law enforcement personnel who are required to demonstrate proficiency with multiple firearms each quarter, and to maintain a constant state of operational readiness through training.

United States Coast Guard (USCG)

USCG safeguards our Nation's maritime interests in the heartland, in the ports, at sea, and around the globe by protecting the maritime economy and environment, defending our maritime borders, and saving those in peril. USCG accomplishes this by performing 11 missions: ports, waterways, and coastal security; drug interdiction; aids to navigation; search and rescue; living marine resources; marine safety; defense readiness; migrant interdiction; marine environment protection; ice operations; and other law enforcement missions.

In almost all of USCG's missions, trained law enforcement personnel are required. The ammunition-related activity identified in this report was necessary to supply ammunition to USCG personnel who are initially qualified and are also required to maintain these qualifications on multiple firearms several times per year to achieve a constant state of operational readiness.

United States Secret Service (USSS)

The mission of USSS is to ensure the security of our President, our Vice President, their families, the White House, the Vice President's residence, national and visiting world leaders, former Presidents, and events of national significance. The USSS also protects the integrity of our currency and investigates crimes against our national financial system.

Currently, the USSS has approximately 4,800 personnel who are authorized to carry firearms in the performance of their duties, and they are required to maintain proficiency with several different firearms. The ammunition purchased by USSS is used to meet firearms requalification and training requirements, as well as to maintain operational readiness (i.e., duty carry).

IV. Ammunition Inventory

The data below show that DHS generally used more ammunition than it purchased over the reporting period, which is due largely to substantial budget reductions during the reporting period. The existing reserve ammunition stocks have helped to offset these shortages in the short term, but increased spending is anticipated in future periods to ensure that DHS maintains adequate ammunition levels to meet mission and training needs. The expansion of a DHS law enforcement inventory, training, and credentialing system will enhance further DHS's ability to track and maintain leaner ammunition stock levels. The following charts show the amount of ammunition (in number of rounds) in inventory at the end of the preceding calendar year, and the amount expended and purchased by type during the year:
