Executive Summary

The FY 2005 DHS Appropriations Act (P.L. 108-334) requires the TSA Administrator annually to transmit a report on the collection of unclaimed money at airports and on the expenditure of those funds. Congress directed TSA to provide an accounting of the amount of unclaimed money recovered in total and at each individual airport. TSA also was directed to describe how that money is being used to provide civil aviation security.

This report provides the amount of unclaimed money recovered from each airport and the total amount recovered during FY 2014, and describes how unclaimed money is being used for civil aviation security.

I. Legislative Requirement

This document constitutes TSA's annual report on the collection of unclaimed money at airports during FY 2014, and the expenditure of those funds as required by the *FY 2005 DHS Appropriations Act* (P.L. 108-334).

Specifically, section 515(b) of P.L. 108-334 states:

(b) ANNUAL REPORT – Not later than 180 days after the date of enactment of this Act and annually thereafter, the Administrator of the Transportation Security Administration shall transmit to the Committee on Transportation and Infrastructure of the House of Representatives; the Committee on Appropriations of the House of Representatives; the Committee on Commerce, Science and Transportation of the Senate; and the Committee on Appropriations of the Senate, a report that contains a detailed description of the amount of unclaimed money recovered in total and at each individual airport, and specifically how the unclaimed money is being used to provide civil aviation security.

II. Background

Unclaimed money is defined as money passengers inadvertently leave behind at airport screening checkpoints during screening. In most cases, this consists of coins passengers remove from their pockets so that metal detectors do not sound. During FY 2014, TSA collected \$674,841.06 in unclaimed money. Receipts of unclaimed money are deposited into a Special Fund account so that the resources can be easily tracked and subsequently expended.

Section 44945 of title 49, United States Code, grants TSA statutory budget authority to expend unclaimed money:

Sec. 44945 Disposition of unclaimed money. Notwithstanding section 3302 of title 31, unclaimed money recovered at any airport security checkpoint shall be retained by the Transportation Security Administration and shall remain available until expended for the purpose of providing civil aviation security as required in this chapter.

III. Unclaimed Money Collections and Expenditures

The following table lists the total amount of unclaimed money collected during FY 2014 by airport. Spoke airports deposit unclaimed money collected at spoke airport checkpoints to their supervising hub airport. The hub airport then deposits the sum total of the hub airport's collection and its reporting spokes' collections, sending receipts of the deposit to TSA headquarters. Amounts recorded to the airports in the following table reflect collected U.S. currency. Because of economies of scale regarding costs of conversion into U.S. currency, all foreign currency is combined before being exchanged into U.S. dollars. During the FY 2014 reporting period, all deposits totaled \$674,841.06, which included \$32,889.18 in foreign currency.

TSA uses these funds to provide Civil Aviation Security in accordance with P.L. 108-334. In FY 2014, TSA collected \$674,841.06 and expended \$3.87 for administrative overhead. The remaining amount is planned for the TSA Pre ✓ ® program expansion.
