**DUTY STATUS:** This is a Drill Status Guard (DSG) position, NOT full-time employment. Applicants are expected to meet all Unit Training Assemblies and Annual Training requirements annually.

***Specialty Summary:*** Manages and performs weather operations for Air Force and Army activities. Integrates current and forecast atmospheric and space weather conditions into operations and operational planning. Develops, directs, and coordinates meteorological and space weather studies and research. Supports and executes weather operations through leadership and management of weather centers, groups, squadrons, and weather flights/detachments. Supports Air Force core weather responsibility to provide meteorological and space weather information for DoD air, ground, and space operations.

***Duties and Responsibilities:*** Lead weather units and elements. Manage AF weather personnel and resources. Analyze and evaluate meteorological data and prepares forecast products. Integrate weather analyses and reports with radar and satellite imagery interpretations to support operations. Brief aircrew and staff personnel on current and forecast weather and its effects on air operations. Instruct personnel on interpretation and use of meteorological products and their application to DoD missions. Provide mission tailored forecasts for special and joint operations. Direct taking, recording, reporting, and decoding of meteorological and space weather observations, analysis of data, preparation of forecasts and other prognostic products. Produce and direct studies to improve forecasting techniques and abilities. Advise commanders and their staffs on capabilities and limitations of weather operations.

***Eligibility Requirements***

***Citizenship:*** Must be a citizen of the United States.

***Physical/Medical Requirements:*** Must be in good physical condition and be medically qualified in accordance with applicable Air Force and Air National Guard regulations.

***Security Clearance Requirement:*** Specialty requires routine access to Top Secret material. For award and retention of AFSC 15W3, completion of a current Single Scope Background Investigation (SSBI) is mandatory.

***Training:*** For award of AFSC 15W3, completion of the Weather Officer Course and completion of Weather Flight/Detachment Officer Course is required prior to first post Operational Weather Squadron assignment.

***Other:*** Meet all other appointment requirements as established in ANGI 36-2005.

Complete **AF Form 24**, *Application for Appointment as a Reserve of the Air Force*, and **AF Form 2030**, *USAF Drug and Alcohol Abuse Certificate* (web site: [www.e-publishing.af.mil](http://www.e-publishing.af.mil)).

Detailed resume of military and/or civilian work and educational experience. All breaks in employment and/or educational pursuit should be fully explained. (Short biographies are NOT acceptable.)

Current Point Credit Summary

Current Physical Fitness Scores

Copies of last three (3) Officer Performance Reports

Conditional Release (If requesting transfer from the Air Force, Air Force Reserve, or ANG of another state)
