1. Situation

- a. Marine Corps Installations National Capital Region-Marine Corps Base Quantico (MCINCR-MCBQ) was officially designated as a subordinate command to Marine Corps Installations Command (MCICOM) in reference (a). As reflected in reference (b), the Commander, MCBQ has been designated a General Court Martial Convening Authority (GCMCA). In addition, the Commander, MCICOM has delegated Commanding General level Request Mast responsibilities to the Commander, MCINCR-MCBQ in reference (c), consistent with reference (d).
- b. Guidelines are set forth in this order to clarify and standardize the submission of Request Mast applications to the Commander, MCINCR-MCBQ. Additionally, the complex command and legal relationships throughout this region can lead to confusion in routing procedures. This order identifies units/organizations to which it applies.
- 2. Cancellation. Commander's Policy Letter 1-14.
- 3. $\underline{\text{Mission}}$. Standardize procedures for the submission and processing of Request Mast applications through the requestor's chain of command to the Commander, MCINCR-MCBQ in accordance with references (c), (d), and (e).

4. Execution

a. $\underline{\text{Commander's Intent}}$. This order applies to all commands for whom the $\underline{\text{Commander}}$, $\underline{\text{MCINCR-MCBQ}}$ serves as the $\underline{\text{GCMCA}}$. The enclosure lists those organizations.

b. Concept of Operations

- (1) Request Mast applications will be submitted in writing and processed in accordance with reference (d), enclosure (1) chapters 3 and 4.
- (2) A Marine desiring to request mast with the Commander, MCINCR-MCBQ, will complete Part I, sections 1-9 and submit the NAVMC Form 11296 unfolded, in a yellow 9x12 envelope.
- (3) The requestor will affix one (1) NAVMC form 11296 to the front of the envelope as a cover sheet with only Part I, sections 1-8a, and section 9 complete. Part I, section 8b, will be left blank on the cover sheet.
- (4) Additionally, if the Marine does not want to reveal the subject of the Request Mast to a subordinate commander, the outside of the envelope will be marked "To be opened by the Commander, MCINCR-MCBQ Only". The envelope will be sealed and the requestor will sign his or her name over the seal before covering the seal with clear tape.
- c. <u>Coordinating Instructions</u>. The Request Mast hearing with the Commander, MCINCR-MCBQ will be coordinated and scheduled via the MCINCR-MCBQ Inspector General (IG).

5. Administration and Logistics

- a. Request Mast applications addressed to the Commander, MCINCR-MCBQ must be hand delivered to the MCINCR-MCBQ IG located in LeJeune Hall, Building 3250, Catlin Avenue, Room 125 or Room 123.
- b. Request Mast applications will be accepted Monday through Friday from 0730-1630.
