



2012 CRS Coordinator's Manual Webinars

The 2012 edition of the *CRS Coordinator's Manual* will take effect no sooner than July 1, 2012. This allows all communities time to review their programs and see how they can improve their CRS classification under the new *Manual*.

A new series of one-hour webinars will be held February through April to explain the changes (including credit points). The webinars are free and are open to everyone.

You must register at least two days before the webinar you wish to attend. Remember that you need to access the site (at the URL that will be sent to you after you register) five minutes before the starting time. 2012 CRS Award Nominations Sought

The National Flood Insurance Program (NFIP) has established an award to recognize individuals who have actively advanced the vision of the NFIP and the Community Rating System (CRS). While all CRS participating communities are taking steps that improve their flood safety and resilience, certain communities stand out.

As in all serious endeavors, outstanding results do not just happen. They are due to the efforts of specific individuals, who through their knowledge, commitment and passion, have made their communities safer. In an effort to recognize such individuals the NFIP is seeking nominations for the 2012 CRS Award for Excellence.

FEMA is asking organizations and their members to help identify worthy individuals. In particular FEMA is looking for nominees who have provided leadership in the area of alerting residents to the dangers of flooding and promoting the purchase of flood insurance through the NFIP. Such an individual could be an insurance or real estate professional, local official, floodplain manager, or other community leader.

The nominee should be:

- Actively involved in a CRS community and knowledgeable about local flooding.
- Active in promoting the use of flood insurance as a key tool in helping individuals prepare for the contingency of flood damage to their properties.
- Active in encouraging community leaders to continually improve the community's safety and resilience related to flooding and other disasters.
- Recognizable as having noteworthy achievements in the area of alerting residents and businesses to potential flood dangers and promoting the purchase of flood insurance.

Training Opportunities

CRS Training on Elevation Certificates

Don't forget that the CRS offers a "remote" workshop to help communities with their elevation certificate requirements. If you are interested in hosting a "webinar" on the FEMA Elevation Certificate or any other activity, contact your ISO/CRS Specialist.

Emergency Management Institute Courses

FEMA's Emergency Management Institute (EMI) conducts courses on floodplain management and other CRS-related topics. These are oriented to local building, zoning, planning, and engineering officials. Tuition is free for state and local government officials and travel stipends are available. - The Community Rating System (E278) August 6–9, 2012; September 17–20, 2012

These courses will use the 2012 edition of the CRS Coordinator's Manual.

Prerequisite: To enroll in the CRS course, you must be a Certified Floodplain Manager (CFM) or have completed the National Flood Insurance Program course listed below (E273) or be a full-time floodplain manager with more than 3 years of experience specifically related to floodplain management.

The CRS course is also offered at other sites upon request. Scheduled so far are the same four day courses. These classes may have room for students from other parts of the country. Contact the State NFIP Coordinator for more information.

- Retrofitting Floodprone Residential Buildings (E279) June 25 28, 2012
- Residential Coastal Construction (E386) August 13 16, 2012

Under Section 431.n, Staffing (STF) and its replacement credit in the 2012 CRS Coordinator's Manual, five points are provided for each member of a community's floodplain permit staff who graduates from courses E194, E273, E278, E282, E284, or E386 (up to 25 points). Graduating from E279 is worth five points under Activity 360–Flood Protection Assistance.
