Transportation

There are a number of transportation alternatives available to UNT students, faculty, and staff. See website for more information.



UNT Shuttles: UNT, in partnership with the Denton County Transportation Authority (DCTA), operates a shuttle bus system that brings students from apartment communities to campus. It also provides limited transportation between campus locations. Students,

faculty and staff may access these buses by showing a valid UNT ID card.

eRide: UNT offers a safe ride program from 9:00 PM until 2:00 AM, 7 days a week. eRide uses minibuses to transport UNT students, faculty and staff between campus locations. Call 940-565-3014 starting at 9pm. See our website for details.

Bicycles: UNT has rack spaces for over 2,500 bikes and several remote bicycle repair stations.

Car Sharing: Coming soon. This is an on campus rental car service that provides 24/7 self-service through the internet or smart phone. Vehicles can be reserved by the hour or by the day.

DCTA Services

DCTA Connect is a city-wide bus system. UNT Students, faculty and staff can access DCTA Connect buses by showing a valid UNT ID Card.

The A-train is a commuter train that runs from Downtown Denton Transit Center to the Dallas Area Rapid Transit (DART) Trinity Mills Station in Carrollton. Discounts available for UNT.



Parking Permits

All parking on UNT campus requires a parking permit unless you park at a meter or in a garage. All permits are ordered at transportation.unt.edu

New for Fall 2016. Eagle Permit (E). Eagle permits are only valid in (E) spaces. Available in two types Eagle Annual (EA) and Eagle Fall (EF). Eagle Fall permits are for students graduating at the end of December only.

Resident (R) permits are valid in (R) spaces only. Resident Garage Access cards are also available. Resident Garage access cards are valid only in the Highland Street Garage.



Motorcycle permits are only valid in motorcycle spaces.



Faculty/staff (FS) permits are valid in both (E) spaces and (FS) spaces.

(FS) permits replace the (D) permits in Fall 2016.



Reserved (A) permits are valid in the assigned A-lot, any (FS) space, and any (E) space.

A handicap placard with a valid UNT permit displayed can park in any ADA accessible space, (E), or (FS) space or any meter (without payment) as long as the vehicle is not parked longer than the meter's time limit.

Parking Tips

The "Dos and Don'ts" of parking on **UNT** campus

have your questions answered by the Transportation Services staff. Other sources may not be up to date.

know all of the parking regulations, available at transportation.unt.edu. This is your responsibility if you park on campus.

Do

observe the signs at the entrance of each parking lot indicating the permit required to park in that lot. Match the color of your permit to the color on the sign and park within the lines to avoid an improper parking citation.

purchase a permit from anyone except Transportation Services. Permits ont purchased elsewhere are invalid and may be stolen, leading to the impoundment of your vehicle.

trade or lend your parking permit to your friends. If a vehicle displaying your permit receives a citation, that citation is your responsibility.

Make sure to pay any parking citations you receive. Vehicles may be impounded for unpaid citations, and holds may be placed on your student account that prevent you from receiving transcripts.

Make sure your visitors purchase one-day Visitor Permits from Transportation Services so they do not receive any citations. Visitors are also welcome to use the Union Circle Garage or parking meters on campus.
