#### **Course Evaluation Methods**

Grade determination: Separate letter grades will not be assigned for the lab. While laboratory accounts for only 30% of your grade, <u>you must receive a passing grade (60% or higher) in the laboratory to receive a passing grade in the class.</u>

This course will utilize the following instruments to determine student grades and proficiency of the learning outcomes for the course.

Lab Assignments (50 points) – We will have a discussion in class and you will write a short essay about it. In addition, you will watch documentaries to complement class content. Each student should turn his/her assignment individually. Each assignment will be worth 10 points and it will be *due at the end of the corresponding lab session*.

Lab Reports (120 points) – You will perform experiments designed to give you hands-on real-world applications of the lecture material. After each laboratory exercise, you will write a lab report worth 20 points. Although you will work in groups to perform the experiments, each student should turn in his/her lab report individually. Specific instructions will be provided in class for each lab report, however all of them will be required to contain the following sections: Introduction, Materials and Methods, Results, Discussion and Conclusion, and Bibliography. *The lab reports will be due at the beginning of the next lab session.* 

Lab Exam (50 points) - You will have one lab exam worth 50 points. This will be a take home exam.

**Student Presentation (40 points)** – This is an *oral presentation* by each student based on the topic that he/she selected and developed for his/her Research Paper.
