<b>Course Goals or Overview:</b>	<b>The goals of this course are as follows -</b>		
	The goal of this course is for students to understand how class, race and gender play in the development of our criminal justice system from past years to today's criminal justice system.		
<b>Learning Objectives/Outcomes:</b>	At the end of this course, the student will		
1	Recognize and understand the basic theories related to the study of race, class, gender and crime.		
2	Examine the various perspectives relevant to the death penalty and the racial and ethnic makeup of persons in the prison population.		
3	Examine the nature of drug crime disparity and criminal records when considering class, gender, and race are involved.		
4	Identify and understand class and economic inequality and privilege when considering who commits major crimes in American society.		

5	Understand the police role, the courts, punishment, sentencing and imprisonment when class, gender and race are involved.
6	Examine crimes by minority youth and racial disparities in the juvenile justice system.
7	Examine victimology & patterns of victimization; understand the law making process & the administration of criminal law.

**Course Evaluation Methods:** This course will utilize the following instruments to determine student grades and proficiency of the learning outcomes for the course.

- Discussion Posts four discussion board postings

**Chapter Quiz Policy:** There will be (4) different chapter unit quizzes over selected chapters from the textbook in each unit. The online part I of the quizzes will be timed and you will have 90 minutes to complete the quiz. Do not leave the quiz for any reason and do not have long periods of non-activity inside the quiz for blackboard will lock you out automatically. Remember each unit chapter assignment has a completion date.

- Each quiz will come from selected chapters in the textbook and worth 100 points toward the students final grade.
- Each quiz will consist of questions both multiple choice, true-false and short answer.
- Each quiz will be broken down into two parts.
- Part I will have a mix of (40) multiple choice and true-false questions worth 2 point each.
- Part II will have (20) short answer questions worth 1 point each. (your answers must be placed on the answer form furnished by the instructor and attached to a message sent to me via the Message Link).
- Five points will be deducted for failing to put your name on the submitted form.

Quizzes must be taken as scheduled. No makeup quiz will be allowed except for documented emergencies (See Student Handbook). If a student gets locked out of a quiz he or she must send me a message via the message link in to course stating why they were locked out and I will unlock the quiz so that the student may take it over. I will only unlock one quiz during the semester and the unlocked quiz must be taken before the unit assignment closing date.

- Did the video(s) and article(s) bother or annoy you? Why or why not?
- What did you realize as a result of watching the video(s) and reading the article(s)?

- What questions does the video(s) and article(s) raise for you about our criminal justice system.
- What would you tell the victims if you had a chance?
- When considering what you have learned, what would you like to see changed if anything in our criminal justice system?

**Information Quiz:**

The information quiz will come from all the material inside the Your Professor Link, the Start Here Link, and the Course Information Link. The quiz will consist of 25 questions worth 2 points each for up to 50 points toward a student’s final grade in the course.

**Discussion Board Postings:**

Each student will be required to post to (4) different discussion board postings during the semester. The discussion board topics will correspond with information from each selected chapter in the textbook. Each student will be required to post to the discussion question asked and then reply to (3) other student’s posts. **Postings will be graded according to the Critical Thinking Value and Written Communication Value in each posting.** The (4) discussion board postings will count up to (25) points each (for a total of 0 – 100 total points) toward a student’s final grade. A completion date will be posted on each discussion question located inside the Discussion Board link.

**Discussion Board Grading:** Discussion board activities and any other grading activities will be graded within 48 hours after the closing of each unit. Instructor will also respond to student Blackboard questions within 24 hours of student posting in the Blackboard’s messaging tool.

**Discussion Board Grading:**

- 0 - 25 points for posting to each discussion question.
- 0 – 100 points for posting to each discussion board question.
- 0-15 pints for posting to 3 other student’s posts. (0-5 points each)
- 0 - 10 total points for the (4) discussion board questions can be earned.
