	This course focuses on substantive criminal law: i.e., basic crimes and criminal defenses. In this connection, we will explore the traditional common law and Texas statutory definitions of the crimes and defenses.

## **Course Requirements, Policies, and Schedule**

This schedule is subject to change by the instructor. Any changes to this schedule will be communicated via announcements in Blackboard. You are also responsible for reading through the course information on Blackboard.

- Unit 1 (located inside the "Start Here" tab) is an introduction to the course. There is an introductory quiz about the online environment and the syllabus that must be completed with a score of 20 before you can begin the academic content section of the course (this counts as your first quiz grade, so everyone gets an A out of the gate after that, it's up to you).
- The academic content contains 4 modules with units (chapters) within each module. Each unit has its own readings and quiz; and each module has its own exam. You will not be able to take the module exam until you have completed at least one attempt on all the unit quizzes within the module.
- The module exam grades will NOT be counted into your final average, but you must achieve at least **70%** in order to get 100% credit for the points earned for the quizzes within that module. If you achieve between 60-69% on the module exam, you will receive 75% of the points earned for the quizzes within that module. You receive no points for the quizzes if your highest module exam score is below 60% or if you simply do not take the exam.
- Quizzes may be taken an unlimited number of times before the deadlines and the highest score will count. You may take the exam for each module twice as long as you complete it before the deadlines below.
- Although the entire course is open from the beginning, the modules have due dates that roughly correspond to
  one module per week. In other words, you can work through the modules faster at the beginning of the term,
  but you cannot procrastinate and complete the work all at once at the end of the term. Module course material
  will remain available throughout the course after the module becomes available, but the quizzes and exams will
  only be available through the deadline for each module.

**Intro Unit and Module 1** – The Intro Unit MUST be completed before you can complete ANY of the Modules. Module 1 consists of Units 2-5 and begins after the introduction quiz at the beginning of the course; Module quizzes and exam must be completed no later than <u>11:59 p.m. on Sunday, July 17</u>.

<u>Module 2</u> – Module 2 consists of Units 6-8; Module quizzes, exam, and discussion must be completed no later than <u>11:59 p.m. on Friday, July 22</u>.

<u>Module 3</u> – Module 3 consists of Units 9-11; Module quizzes, exam, and discussion must be completed no later than <u>11:59 p.m. on Friday, July 29</u>.

<u>Module 4</u> – Module 4 consists of Units 12-15; Module quizzes, exam, and discussion must be completed no later than <u>11:59 p.m. on Sunday, August 7</u>.

## Legislative Inquiry Assignment and Due Dates:

For this assignment, you will locate two bills that have been proposed to affect Texas criminal law (adding a new crime, changing the definition of a current crime, or affecting the punishment of an offense).

For each of the bills you select, you will write an analytical paper that has two major parts:

- 1. General information about the bill
- 2. Your personal analysis of the bill

The first Legislative Inquiry will be based on the content in the first two modules and will be due when Module 2 is due. Feedback will be provided and you will be allowed to revise and resubmit this inquiry within 3 days of the day I return it to you if you would like to try to improve your grade. The second Legislative Inquiry will be based on the content in the second two modules and will be due when Module 4 is due and the first submission is a final submission.

Further details for this assignment, including guidelines and a rubric, are provided in the course page in Blackboard labeled "Legislative Inquiry."


## Incompletes:
