Exam Policy:

Four exams will be given (one at the end of each learning module). The exams may consist of multiple choice, definition, matching, true/false, and short answer questions. You can also expect there to be an essay question with an ethical dilemma for you to evaluate on each exam. If the exams are not given online, paper will be provided with the exam for you to write on. You must bring a #2 pencil and a green scantron form with you for each exam. There will be no make-up exams unless you have a documented university-recognized emergency. If you must miss an exam, you must notify me prior to the exam that you will have to reschedule.

NO CELL PHONES WILL BE PERMITTED DURING THE EXAMS. YOU WILL BE SUBJECT TO A 10-POINT DEDUCTION ON YOUR EXAM FOR A VIOLATION OF THIS RULE. THIS INCLUDES A RINGING OR AUDIBLY VIBRATING CELL PHONE OR USE OF TEXT MESSAGES. As a courtesy, please do not bring food or drink to class during exams. During exams, ALL ITEMS other than what is needed to take the exam (exam, scantron, and a pencil) must be under your desk.

You will have an hour to complete the exam once it starts. No additional time will be given if you are late. There is typically a bonus question on each exam. However, if you are late for an exam that has a bonus question on it, you will forfeit the privilege to receive those points.

Discussions policy:

You will be required to participate in discussions online as well as in class. These online discussions will be evaluated for your comprehension of competing perspectives, and ability to form rational arguments that justify different ethical positions. Each student is required to:

- Initiate at least one unique online discussion topic relevant to each of the four modules; and
- Respond to at least five discussion topics posted by other students within each module

Please do not submit questions related to specific personal concerns to the discussion forums, even if presented as hypothetical situations. Questions related to relevant current events in the news are permitted, and students are also encouraged to use the Criminal Justice Ethics journal for topical ideas. Students must demonstrate originality and thought in their proposed topics. Each topic and response will be evaluated on a 4-point scale:

- 0. No topic or response was provided during the module
- 1. Original post or responsive post contributes little or no evidence of reflective thought regarding the course content, personal perspectives, opposing perspectives, or professional development, to the discussion. Uses significant "txt spk" instead of appropriate grammar and spelling.
- 2. Some evidence of independent and reflective thought, but mostly pertains to personal opinion unsupported by course content. Some reflection on professional development. Uses some "txt spk" instead of appropriate grammar and spelling.
- 3. Average contribution with some evidence of original thought supported by course content; shows general respect for peers' contributions but does not contemplate them in the response.
- 4. Excellent contributions that contemplate opposing views respectfully and sensitively to peers' viewpoints, while supporting personal opinions with evidence; relate to the further professional development of students.

Nothing in this policy is intended to limit or restrict lively debate or discussion of additional topics of interest to the class, so long as students remain respectful. Please remain on topic within each thread of discussion (responding to a specific thread within the thread, rather than responding or starting a different thread to respond). Discussions are due for each module prior to the exam for that module.

Assignment policy:

Every student must complete a reflection paper at the end of the course. It must follow the criteria given in the Ethics Reflection Paper handout posted on Blackboard, and will be assessed based on the rubric provided. The paper must address: (1) how exposure to different ideas, perspectives, cultures and viewpoints have enriched the student's thinking; (2) the decision making strategies (including ethical analysis) learned; and (3) how what has been learned in the student's academic career will encourage them to recognize and be open to constructive change. It should be organized with an introduction, body, and conclusion, and should be written from the student's perspective. It must also contain the honor code statement given in the section on Academic Integrity below. The reaction paper is due at the beginning of class on April 26, 2012.

The reflection paper will be graded based on the rubric provided on Blackboard, with the following percentages applied: content (90%); and organization, grammar, punctuation and spelling (10%). I encourage you to utilize the services at the UNT Dallas writing lab to proofread your assignments and maximize the points received. **ASSIGNMENTS ARE DUE WHEN CLASS STARTS**; Assignments turned in after class begins will be penalized 5 points if turned in the same day, plus an additional 10 points per calendar day after that. **Papers will not be accepted more than 3 calendar days late (total 35 points off).** If you will not be in class or will be late to class for some reason, email your reflection papers to me BEFORE the class in which they are due.

Incompletes:

Pursuant to University policy, incompletes will not be given unless ALL of the following conditions have been met:

- (1) the student has completed 3/4 of the class
- (2) the student is currently passing the course, and
- (3) the request for an incomplete is pursuant to a University-recognized reason (medical emergency or military deployment).

Extra Credit:

On occasion, I have assigned extra credit to various classes. If offered, it is a privilege and an opportunity, not a right or an obligation. If extra credit is assigned in class, depending on the nature of the assignment, turnitin.com may be used as a tool. An acknowledgement sheet is required to be submitted to me prior to any assignment due date if turnitin.com is used. I do not give individual extra credit opportunities under any circumstances.
