## Course Evaluation Methods

This course will utilize the following instruments to determine student grades and proficiency of the learning outcomes for the course.

### Discussion Posts

Each student will be required to post to (4) different discussion board postings during the semester. The discussion board topics will correspond with information from each selected readings. Each student will be required to post to the discussion question asked and then reply to (2) other student's posts. **Postings will be graded according to the Content and Grammatical Value in each posting.** Completion date will be posted on each discussion question located inside the Discussion Board link.

### Discussion Board Grading:

- 0 - 100 points for posting to each discussion question.
- 0 - 400 total points for the (4) discussion questions can be earned.
- 0 - 60 total points for posting to 2 other student's posts.

### Exercises - case studies, critiques, etc.

Exercises will consist of a variety of video critiques. Grading guidelines are the same as for discussion board postings.
