<b>Course Catalog Description:</b>	This course focuses on prisons and jails. It examines the goals and history of punishment; the death penalty; the composition and social organization of jail and prison populations; bail, detention, sentencing and classification; institutional management and the conflicts between rehabilitation and punishment.

<b>Course Goals or Overview:</b>			
	The goal of this course is to engage the reader about the correctional system. This course directly addresses the most crucial questions and concerns about the corrections system while challenging the stereotypes that guide to current prison policies.		
<b>Learning Objectives/Outcomes:</b> At the end of this course, the student will			
1	Be able to understand corrections.		
2	Demonstrate the ability to understand the punishment of offenders.		
3	Define probation and intermediate sanctions.		
4	Identify the role of corrections at the local level.		
5	Understand prison management and staffing within the prison subculture..		
6	Understand the issues of a growing population of mentally ill, aging, and AIDS within prison.		
7	Identify legal issues from the inmate to the U.S. Supreme Court concerning the death penalty.		

8	Recognize the sentencing process.
9	Discuss the issues and challenges in managing prisons.
10	Understand the dual functions of probation; parole; community reentry; investigation and supervision.
11	Understand youth crime and the development of juvenile corrections in the U.S.
12	Identify and discuss reducing recidivism for people reentering society.

### Quiz Lockout:

**Chapter Quiz Policy:** There will be (4) different chapter unit quizzes over selected chapters from the textbook in each unit. The online part I of the quizzes will be timed and you will have 1 ½ hours (90 min.) to complete the quiz. Do not leave the quiz for any reason and do not have long periods of non-activity inside the quiz for blackboard will lock you out automatically. Remember each unit chapter assignment has a completion date.

- **Each quiz will come from selected chapters in the textbook and worth up to 100 points toward the student's final grade.**
- **Each quiz will consist of questions both multiple choice, true-false and short answer.**
- **Each quiz will be broken down into two parts.**
- **Part I will have a mix of (40) multiple choice and true-false questions worth 2 point each.**
- **Part II will have (20) short answer questions worth 1 point each. (all answers must be placed on the answer form furnished by the instructor and attached to a message sent to me via the Message Link).**
- **Five points will be deducted for failing to put your name on the submitted form.**

### Writing Assignment:

- The written assignment will be located inside the CJUS 3300.030 / SOCI 3460.030 Course Assignment Folder.
- The assignment will be worth up to 100 points toward your final grade in the course.
- Five points will be take off for each day the assignment is late.
- Ten points will be taken off for failing to put your name on the submitted assignment.

### Once you have completed the assignment, the following procedures will be used to submit it for grading:

- Click on the Message Link.
- Click on Create Message.
- Click on TO.
- Locate my name in the select recipient's box and click on it. (it will turn blue)
- Click on the top arrow between the two boxes to move my name into the recipient's box.
- Type **My Completed Writing Assignment** into the Subject box.
- Click on the Browse button and attach your document. (documents must be saved as a word document before sending)
- Click on Submit.
- The assignment must be turned in on or before the due date. Five points will be deducted for each day the assignment is late.

**Discussion Board Postings:**

Each student will be required to post to (4) different discussion board postings during the semester. The discussion board topics will correspond with information from each selected chapter in the textbook. Each student will be required to post to the discussion question asked and then reply to (3) other student's posts. **Postings will be graded according to the Critical Thinking Value and Written Communication Value in each posting.** The (4) discussion board postings will count up to (25) points each (for a total of 0 – 100 total points) toward a student's final grade. A completion date will be posted on each discussion question located inside the Discussion Board link.

**Discussion Board Grading:** Discussion board activities and any other grading activities will be graded within 48 hours (Monday through Friday) after the closing of each unit. Instructor will also respond to student Blackboard questions within 24 hours (Monday through Friday) of student posting in the Blackboard's messaging tool.

**Discussion Board Grading Rubric:**

- 0 - 25 points for posting to each discussion question.
- 0 - 100 total points for the (4) discussion questions can be earned.
- 0 - 10 total points for posting to each discussion board question.
- 0 - 15 total points for posting to 3 other student's posts. (0-5 points each)
