<b>Course Goals or Overview:</b>	
	The goal of this course is to give student a better understanding of how the juvenile justice systems works work in conjunction with law enforcement, the courts, and corrections within the criminal justice system.
<b>Learning Objectives/Outcomes:</b> At the end of this course, the student will	
1	Be able to understand the social, historical and political structure and processes that impact juvenile justice
2	Be able to explain the juvenile justice system structure and process
3	Demonstrate the ability to understand the theoretical foundations of the juvenile justice system in the U.S.
4	Define important concepts related to the understanding of juvenile justice in the U.S.
5	Identify important and significant court cases related to juvenile justice.
6	Be able to demonstrate the role law enforcement, the juvenile court system, and corrections play in the juvenile justice system.

### Course Outline

**Course Evaluation Methods:** A student's final grade will be calculated from the following means.

- four examinations that will be given over material covered in the required textbook
- one information quiz
- four discussion board postings
- one practical exercise

**Chapter Quiz Policy:** There will be (4) different chapter unit quizzes over selected chapters from the textbook in each unit. The online part I of the quizzes will be timed and you will have 1 hour (60 min.) to complete the quiz. Do not leave the quiz for any reason and do not have long periods of non-activity inside the quiz for blackboard will lock you out automatically.

Remember each unit chapter assignment has a completion date.

- Each quiz will come from selected chapters in the textbook.
- Each quiz will consist of questions both multiple choice, true-false and short answer.
- Each quiz will be broken down into two parts.
- Part I will have a mix of (30) multiple choice and true-false questions worth 2 point each.
- Part II will have (20) short answer questions worth 2 points each. (answers must be placed on a answer form furnished by the instructor and attached to a message sent to me via the Message Link).

Quizzes must be taken as scheduled. No makeup quiz will be allowed except for documented emergencies (See Student Handbook). If a student gets locked out of a quiz he or she must send me a message via the message link in to course stating why they were locked out and I will unlock the quiz. so that the student may take it over. I will only unlock one quiz during the semester and the unlocked quiz must be taken before the unit assignment closing date.

### PRACTICAL EXERCISE REQUIREMENTS:

Watch the video(s) and read the articles provided for your practical exercise. The paper must be at least 4 pages long and no more than 6 pages. Use number 12 font and double space.

In your reaction paper attempt to answer the following questions:

- Did the video(s) and article(s) bother or annoy you? Why or why not?
- What did you realize as a result of watching the video(s) and reading the article(s)?
- What questions does the video(s) and article(s) raise for you about our criminal justice system.
- What would you tell the victims if you had a chance?
- When considering what you have learned, what would you like to see changed if anything in our criminal justice system?

**Once you have completed the assignment, the following procedures will be used to submit it for grading:**

- Click on the Message Link.
- Click on Create Message.
- Click on TO.
- Locate my name in the select recipients box and click on it. (it will turn blue)
- Click on the top arrow between the two boxes to move my name into the recipients box.
- Type **My Completed Practical Exercise** into the Subject box.
- Click on the Browse button and attach your document. (documents must be saved as a word document before sending)
- Click on Submit.
- The assignment must be turned in on or before the due date. Five points will be deducted for each day the assignment is late.

### Practical Exercise (Reaction Paper) Assignment:

There will be one (1) practical exercise assignments in the course. The exercise will be worth from 0 – 100 points toward the student's final grade in the course.

### Information Quiz:

The information quiz will come from all the material inside the Your Professor Link, the Start Here Link, and the Course Information Link. The quiz will consist of 20 questions worth 5 points each for up to 100 points toward a student's final grade in the course. The quiz will be timed and you will have **30 minutes to complete the quiz.**

### Discussion Board Postings:

Each student will be required to post to (4) different discussion board postings during the semester. The discussion board topics will correspond with information from each selected chapter in the textbook. Each student will be required to post to the discussion question asked and then reply to (3) other student's posts. **Postings will be graded according to the Critical Thinking Value and Written Communication Value in each posting.** The (4) discussion board postings will count up to (25) points each (for a total of 0 – 100 total points) toward a student's final grade. A completion date will be posted on each discussion question located inside the Discussion Board link.

**Discussion Board Grading:** Discussion board activities and any other grading activities will be graded within 48 hours after the closing of each unit. Instructor will also respond to student Blackboard questions within 24 hours of student posting in the Blackboard’s messaging tool.

**Discussion Board Grading:**

- 0 - 25 points for posting to each discussion question.
- 0 - 100 total points for the (4) discussion questions can be earned.
- 0 - 10 total points for posting to each discussion board question.
- 0 - 15 total points for posting to 3 other student’s posts. (0-5 points each)
