Students who are absent for class will not be able to receive the maximum number of class participation points.

*Attendance is required for all class presentations. I will deduct 5 points from your final grade for every class you miss during class presentations.

*If you are not in class at the time you are scheduled to make your presentation you will score a zero for the entire assignment.
