#### Course Evaluation Methods

This course will utilize the following instruments to determine student grades and proficiency of the learning outcomes for the course.

**Exams** – Three exams will be given. The exams are worth 75% of your final grade.

**Presentations** – You will be required to individually (not with other students) give a <u>15 minute oral class</u> <u>presentation</u> regarding issues in Victimology as well as provide me a one to two page paper about your presentation. The presentation and aforementioned paper will constitute 15% of your final grade. A handout will be given in class with information on possible topics as well as requirements.

**Class Participation** —Participation means being prepared to answer when called on by the instructor to answer questions relevant to the chapters and/or topics discussed in class. Class Participation points constitute 10% of your grade. Students who do not participate in class discussions and/or students who are not prepared to answer questions when called upon by instructor will not receive class participation points.

\*Attendance is required for all class presentations. I will deduct 5 points from your final grade for every class you miss during class presentations.

\*If you are not in class at the time you are scheduled to make your presentation you will score a zero for the entire assignment.

\*I will deduct 5 points from your presentation grade if you do not hand in your presentation paper at the time you make your presentation.
