Information Quiz:

The information quiz will come from all the material inside the Your Professor Link, the Start Here Link, and the Course Information Link. The quiz will consist of 20 questions worth 5 points each for up to 100 points toward a student's final grade in the course. The quiz will be timed and you will have 1 hour to take the quiz.

Discussion Board Postings:

Each student will be required to post to (4) different discussion board postings during the semester. The discussion board topics will correspond with information from each selected chapter in the textbook.
