8	Recognize the differences between male and female criminality and victimization.
9	Discuss the issues and challenges in the criminal justice system in dealing with homosexuals, including gay police officers, juror bias against gays, and homosexuality in prisons.
10	Understand victimization patterns for elderly.
11	Understand how the historical development of policing relates to current concerns regarding multiculturalism.
12	Identify how sentencing practices and sentencing structures have contributed to the overrepresentation of minorities in prison.
13	Identify and discuss the critical issues challenging the future of multiculturalism and criminal justice.
