Course Goals or Overview:			
The goal of this course is to engage the reader and examine all facets of the criminal justice system as well as several related matters of interest to prospective and current administrators. This book will also give an overview of the primary people, practices, and terms that are utilized in justice administration.			
Learning Objectives/Outcomes: At the end of this course, the student will			
1	Be able to understand the study and scope of justice administration.		
2	Identify innovative techniques for recruiting the best police officer; “good politics, bad politics”; using social networking sites for background checks.		
3	Understand intelligence-led policing; predictive policing; fusion centers; reorganization since 9/11; federalization and militarization of police; legal and psychological aspects of police uniforms and dress codes.		
4	Identify the role of judges’ use of social networking sites.		
5	Discuss the issues and challenges in managing corruptions; jail administrators’ duties; motivating and retaining personnel.		

6	Understand ethics training for federal judges.
7	Understand the First Amendment challenges concerning religious expression; religious expression personal appearance (uniforms, beards); federal, state, and local Hatch Acts; amendments to the Family Medical Leave Act; sexual harassment of males.
8	Recognize the recent political battles over collective bargaining; the labor-management relationship (or “navigating the waters of unionization”)
9	Recognize the “CSI Effect”; courthouse shootings; veterans’ courts; research concerning mental health courts; methods of disposing of cases in a timely manner.
10	Understand disciplinary policies and practices.
11	Recognize labor relations in criminal justice.
