Standard percentages apply to letter grades so 90-100% is an A and you can calculate the points needed for these percentages by multiplying the percentage (90% for example) by the total points possible (1020 in this course) to get the final point totals you need for an A (918).

Note: The lab is worth 24% of your final overall grade for the course. However, you must receive a passing grade (60% or higher) in the laboratory exercises over all to receive a passing grade in the class. Students must pass both the lecture and the lab independently to pass the course (i.e. if you fail the lab, you automatically fail the entire course and if you fail the lecture, you automatically fail the course). There are NO EXCEPTIONS to this requirement.
