Course Evaluation Methods

This course will utilize the following instruments to determine student grades and proficiency of the learning outcomes for the course.

Lab Quizzes (100 points) – Before starting each laboratory exercise you will be given a short quiz (~10 min) to assess how well prepared you are for that day's lab by reading the background information and procedures covered in the manual. Each quiz will be worth 10 points.

Lab Reports (100 points) – Two complete lab reports will be required, each worth 50 points (see Laboratory Schedule above). Instructions on how to write the lab reports start on page 15 of the lab manual and they will be discussed during the first lab session. *The lab report is due at the beginning of the indicated lab session.*

Laboratory Practical Exams (200 points) – Two exams will be given and they will consist of a combination of short answer and fill in the blank questions that require identification and mastery of lab topics, materials and equipment, as presented in the lab manual and discussed during the lab sessions.
