Course Evaluation Methods

This course will utilize the following instruments to determine student grades and proficiency of the learning outcomes for the course.

Course Work (550 points)- 1 Weekly discussion Board, 5 Weekly Assignment Questions, Course work posted on the Blackboard page and due weekly.

Laboratory – You will perform experiments designed to give you hands-on real-world applications of the lecture material. In some cases, you will watch documentaries to complement the experiments, other times we will work outside on a campus project. You will have 2 lab exams worth 40 points each. After each laboratory exercise, you will have an assignment worth 10 - 20 points, for a total of 170 points. Each assignment is due at the beginning of the next lab session. You do not receive a separate grade for lab, so the points received for the laboratory (out of 250) will be added into the lecture grade calculation. Note: The lab is worth 25% of your final overall grade for the course. However, students must pass both the lecture and the lab independently to pass the course (i.e. if you fail the lab, you automatically

Grade Determination:
