<b>Course Catalog Description:</b>	<p><b>Survey of Mathematics with Applications and Algebra Review.</b>  <b>4 hours. (3;1)</b>            An alternate version of MATH1580 for students identified in the mathematics placement process as requiring supplemental instruction to strengthen their algebra skills. A grade of C or better is required for this course to serve as prerequisite. MATH 1580/81 is not intended to prepare students for calculus, science, engineering or business courses.            Students may not receive credit for both MATH 1580 and MATH 1581. Satisfies the Mathematics requirement of the University Core Curriculum.</p>		
<b>Course Description:</b>	Survey of Mathematics with Applications: Topics include probability, statistics, algebra, logic and the mathematics of finance. Additional topics are selected from geometry, sets, cryptography, fair division, voting theory and graph theory. Emphasis is on applications. Recreational and historical aspects of selected topics are also included. Technology is used extensively.
