## **Course Evaluation Methods**

This course will utilize the following instruments to determine student grades and proficiency of the learning outcomes for the course.

**Syllabus Assignments** – The assignments will be given to students on January 26<sup>th</sup>, February 16<sup>th</sup>, March 8<sup>th</sup>, and April 12<sup>th</sup>. Students will be expected to complete the assignments by the appropriate due date.

Weekly Assignments - This semester, students will be assigned weekly assignments related to the topics

discussed to be completed outside of class time.

**Participation** – A healthy class experience is dependent upon not only the instructor, but also instructor-student and student-student interactions. This class not only incorporates a manageable amount of readings, but also injects "real-world" exercises that allow students to put theory in to practice. Poorly prepared students not only affect their own grades, but diminish the overall learning experience of his or her classmates.

**Mid-Term Exam** – The mid-term exam will be handed out on March 1<sup>st</sup> and will be completed at home. It is due March 8<sup>th</sup>. This will be a series of short answer questions and an essay.

**Final Exam** – The final exam will be administered on May 10<sup>th</sup>. This will be a series of short answer questions and an essay. The student will be responsible for bringing a blue/green book for completion.
