Assignment Policy:

Homework assignments are designed to assist in understanding the chapter material. You may rework the homework assignments as many times as you like, and I encourage you to do them until you feel comfortable with the process. You are not graded on your homework; the result of your efforts with homework will be evident in your exam grades. You must read the chapter assignment before class and be prepared to discuss it. I will not lecture, rather I will lead discussions on the chapter topics and work some homework problems as time permits. If you are not prepared you will not be able to learn. Team assignments will be based on the finished product and the presentation by the team. All team members must participate in the preparation and presentation of team results. All team members will receive the same point score; team members who do not participate will get no points. Team assignments will be explained in detail at the appropriate time in class and in the written assignment. Research topics will be assigned each team, and the finished product will be submitted electronically through Turnitin on Blackboard; the presentations will be a synopsis of the results of the research. Length of the final paper will be no more than 12 double-spaced pages, including end/footnotes. APA format is required; failure to seek assistance from the Writing Center will almost certainly result in a lesser grade.

Exam Policy:

Exams should be taken as scheduled. No makeup examinations will be allowed except for documented emergencies (See Student Handbook).

Students are responsible to notify the instructor if

they are missing class and for what reason. Students are also responsible to make up any work covered in class. It is recommended that each student coordinate with a student colleague to obtain a copy of the class notes, in the event of absence.

Diversity/Tolerance Policy:

Students are encouraged to contribute their perspectives and insights to class discussions. Other Policies:

- Use of Publisher Learning Management Systems/Blackboard. Blackboard and learning

 since homework and some exams are administered through that medium.
- Use of Cell Phones & other Electronic Gadgets in the Classroom. Cell phones are permitted in the classroom, but must be set to "vibrate" or "silent" during class. Answer calls outside, if you must, but cell phone conversations, texting, and similar activities will not be permitted in the classroom.
