<b>Course Catalog Description:</b>	ACCT 5130. Accounting for Management. 3 hours. Designed to provide an understanding of managerial accounting data in making business decisions. Cases, readings and projects are used to examine a wide variety of managerial topics.

<b>Course Goals or Overview:</b>	The goal of this course is to expand the student's knowledge of cost management concepts; cost accumulation and cost allocation; budgeting and forecasting; cost and variance measures; performance measures for manufacturing processes and entities; pricing decisions; capital budgeting techniques.
<b>Learning Objectives/Outcomes:</b>	At the end of this course, the student will be able to
1	Define cost management concepts and apply them to cost accumulation systems and to cost allocation.

2	Recognize various cost accumulation systems and know how and when to implement each.
3	Prepare, analyze, and apply budgeting concepts applicable to business managers.
4	Evaluate and apply a variety of cost and variance measures.
5	Measure the performance of the entity as well as be able to help it continuously improve.
6	Identify and apply pricing decisions for budgeting, operations, and strategic purposes.
7	Apply capital budgeting techniques to learn how to better allocate capital for the success of the enterprise.

## Course Evaluation Methods

I will not lecture, rather I will lead discussions on the chapter topics and work some homework problems as time permits. If you are not prepared you will not be able to learn. Team assignments will be based on the finished product and the presentation by the team. All team members must participate in the preparation and presentation of team results. All team members will receive the same point score; team members who do not participate will get no points. Team assignments will be explained in detail at the appropriate time in class and in the written assignment.

**Exam Policy:**

Exams should be taken as scheduled. No makeup examinations will be allowed except for documented emergencies (See Student Handbook).
