Register with the Internship/Co-op office by going to: <u>www.coop.unt.edu</u> and completing the student registration and uploading your resume. If you wish to get help with your resume, please email Beth Kent at <u>beth.kent@unt.edu</u> and include your resume so she can suggest any revisions for you. You will be activated and gain access to the database of internships available to you. You should also pursue on your own any companies you are interested in by researching them online. <u>You may not receive internship</u> credit for a current job or position unless you will have substantially different responsibilities. All internships must be with a business located in a commercial business space and be a paid position. The internship should last a complete semester, either regular long semesters or a ten week summer semester. All interns must complete 240 hours of work during their internship.

# **Course Evaluation Methods**

This course is a Pass / Fail course. The grade is decided by the instructor based on evaluations by the employer, the student, and the LSCM Internship Coordinator.

## Grade Determination:

A = 100 - 90 pts; i.e. 90% or better B = 90 - 80 pts; i.e. 80 - 89% C = 80 - 70 pts; i.e. 70 - 79% D = 70 - 60 pts; i.e. 60 - 69%F = 60 pts or below; i.e. less than 60%
