<b>Course Catalog Description:</b>	An in-depth study of the process of preparing and presenting financial information about an entity for outside users. Topics vary but typically include: standard setting; the accounting cycle including data accumulation, adjustments and preparation of financial statements; and valuation. There is a focus on the recognition, measurement and disclosure of revenue; inventory and cost of sales; and plant assets.	
<b>Prerequisites:</b>	ACCT 2010, 2020 with a grades of C or better; ECON 1110; and MATH 1190 or MATH 1400 or MATH 1710. This course may not be taken more than twice at UNT or at another college or university. Students may not retake this course once they have completed (with a grade of C or better) a course for which this is a prerequisite.

## Course Evaluation Methods

This course will utilize the following instruments to determine student grades and proficiency of the learning outcomes for the course.

**Exams** – There will be four exams and a comprehensive final exam. The four best exam grades will be used to determine your final grade.

**Research Case** – You will be given an accounting case and will complete accounting research related to that topic. Your grade will be based on clear and concise written communication as well as correct research answers.

**Homework** – You will use Connect Accounting to complete and submit your homework problems. No other submission method will be accepted. The due dates and times are included in the assignments. Late work will not be accepted. You may work and rework the Homework assignments as many times as you want within the time window. All of your grades will be reported to me, and I will record the best grade for each assignment.
