**Exams:** Three exams will be administered during the semester as per the attached course schedule. Exams will cover material from specific chapters as noted on the class schedule.

- a. It is required that you take each of the Exams in this course.
- b. When you take an Exam, the grade will be recorded and CANNOT be dropped.
- c. If you miss an Exam a zero will be recorded.
- d. If you miss an Exam and have an excused absence, your score on exam III will replace the previously recorded zero. This substitution can occur for only one missed exam. Any other missed exam (regardless of the reason for missing the exam) will retain the recorded score of zero. **Make-up exams are not given.**
- e. The Exam dates are listed on the attached Class Schedule. Please be advised that the dates are **subject to change**. Any change will be announced in class.
- f. Should you have to miss an exam, it is your responsibility to notify me **BEFORE** the exam takes place.

#### Quizzes:

- Quizzes will be given during class meetings or on line.
- In class quizzes may be given at any time during class period (beginning, middle, or end).
- If you are not in your seat in the classroom when the quiz begins, you will not be allowed to take the quiz. No make-up quizzes will be given.
