- 1) Exams. Students will take two tests and a final exam through the course of the semester. Each test will be worth 40 points. The final exam will not be comprehensive.
- 2) <u>Make-up tests</u> will be essays and will only be given with proper documentation for university-excused absences. Students are responsible for all materials covered if absent and for contacting me immediately to schedule make-up tests.
- 3) Newspaper or internet articles. At the end of each class, each student can submit a neatly presented article about some issues pertaining to American or Texas government and a two-paragraph typed summary (at least three sentences per paragraph) of that article. Only one article and summary will be accepted on the day of the class, and the student must attend class to submit the article and summary. Students CANNOT submit articles for other students.
