- **4.** Identify possible diagnoses for your subject and submit a list of options for Axes I, II, III, IV, and V. Directions will be provided in class. You may identify more than one possible diagnosis for all Axes. For each diagnosis you select on Axes I and II, provide a list of the symptoms your famous person appears to have for each disorder you list. Due April 20th. **50 Points.**
