Course Goals or Overview:	
The aim of this course is to provide a background in several core areas of the study of human language: phonetics and phonology (sound structure and patterns), morphology (word structure), syntax (sentence structure), and socio-linguistics (language use and style). Additional topics to be addressed include dialects, social aspects of language variation, and language change.
