Course Goals or Overview:	<p>The goal of this course is for students to extend their knowledge of the genres of children’s literature and execute the following: evaluate, analyze, describe, select and use a variety of children’s literature as an integral part of the curriculum and classroom. Students will gain an appreciation of the value of children’s literature in the lives of children and the importance of reading and using children’s literature across the curriculum.</p> <p>The goal of this course is to develop in the following 10 areas of competence: They are: Learning Objectives/Outcomes: At the end of this course, the student will have learned and applied the following:</p> <ol style="list-style-type: none">1 Understand and appreciate the culture, language, emotions, experiences, traditions and the intellectual abilities of the people as depicted in children’s multicultural literature books.2 Demonstrate the ability to evaluate and select children’s books appropriate for the classroom.3 Understand the illustrator’s art techniques used as a communication and visual form in a story.4 Develop activities that promote learning and evaluating various components of children’s literature.5 Develop strategies for using children’s literature with a variety of age groups and multiple learning settings.

- 6 Analyze a variation of children's literature, such as fairy tales, picture books, comics, biographies, multicultural, fantasy, legends, myths, school stories, and adventure stories.
- 7 Know different forms of poetry, verse, rhymes, songs and the images of poetry included in children's literature.
- 8 Understand the structure, content, and genre of various texts used for instruction within content areas.
- 9 Demonstrate an ability to plan cross-curricular instruction, which addresses the needs of all learners in content classrooms.
- 10 Demonstrate through written narratives an understanding of various topics related to children's literature.

Course Evaluation Methods

Assessment Philosophy- This is a performance-based course. Grading for this course will be based on performance related to specific course requirements. *Performance is considered on a continuum of understanding and practice that will take place across time and will be considered on an **individual basis**.*

Do not compare your performance to that of other students. Grades are weighted by categories.

Students should be aware that simply completing an assignment does not merit the total number of possible points. The following guidelines will be used in determining points earned. All scored materials are kept by the professor after candidates have reviewed them. Therefore, candidates need to keep a paper copy and an electronic copy of each document submitted.

If you are expecting a final grade of "A," do "A" work on every assignment, regardless of the weight.

Professional Disposition- requirement across all assignments

BLACKBOARD is the course management system that will be used heavily in this class as a form of obtaining course content, communication & assignments. It is the student's responsibility to familiarize him/herself with Blackboard. **Students will not generally receive hard copy handouts.** Electronic copies and links will be provided for the student to download and make paper copies. All students are responsible for checking their email address as listed on the website for this class. If your email address is not correct, you may miss assignments and updates on visits to the public schools. All students will be responsible for regularly checking the class website for announcements, assignments, discussion board and other pertinent information.

Late or Missed Assignments:

1. It is my assumption that all work will be turned in on time. Assignments are due at the BEGINNING of class on the due date. Late assignments are accepted only once at the discretion of the professor, and, if accepted, scores are reduced by 10 pts. You will only have 2 days (after the missed day) to hand in a late assignment.
2. Missed exams may be taken *at the discretion of the professor* and the score will be reduced by at least 10% of the available points. There is no provision for make-up of in-class activities such as QW, in class projects, quizzes or the final exam.
3. The professor will retain all scored documents for her records. Therefore, students must keep a paper copy and an electronic copy for their portfolio and their own records.

The first day of class, you will join a group of four. You will work in this group for a variety of purposes throughout the semester. Responsibilities within the group will be:

- ✓ Support in lesson planning and reflection
- ✓ Collect all missed assignments and cover content missed in class
- ✓ Act as a "reminder" and "check point" for all assignments
