	The goal of this course is to introduce students to advanced U.S. federal taxation topics, with an emphasis on the taxation of business entities.

4	Understand basic concepts relating to advanced taxation topics, including exempt entities, multistate corporate taxation, taxation of international transactions, tax practice and ethics, the federal gift and estate taxes, and income taxation of trusts and estates.		
5	Demonstrate the ability to prepare federal income tax forms for business entities.
