Pursuant to the authority and mandate of Section 3455 (a) (3) (A) of reference (c) and reference (e), the DON Principal Deputy CIO is hereby designated as the Department of the Navy Senior Information Assurance Officer (SIAO). Prior SIAO designations, references (f) and (g), are hereby cancelled.

The DON SIAO has the responsibility and performs the function of the "senior agency information security officer" referenced in Section 3544 (a) (3) (A) of reference (c). In carrying out the SIAO responsibilities, the DON SIAO will facilitate alignment and consistent application of Information Management (IM), Information Technology (IT), and IA policies, processes, responsibilities, and procedures across the Department. The DON SIAO provides oversight and ensures maintenance of network security throughout DON networks.
