The purpose of this memorandum is to further clarify the manner in which reference (a) applies to Microsoft products. Microsoft Software Assurance (SA) is provided under Microsoft's licensing model and provides features essential to prevent operational and security vulnerability risks posed by unsupported software (SW). The SA features include SW product support, SW product updates and other features for effective use of Microsoft operating systems and other server and desktop applications such as deployment planning services. With SA, the Department of the Navy (DON) will also have access to Windows 7 Enterprise with additional security and license rights for virtualization. Windows 7 Enterprise is available only to SA customers.

As part of the DON Information Technology (IT) efficiencies initiatives (references (b), (c) and (d)), the DON is migrating its Microsoft licensing into a DON-wide Microsoft Enterprise License Agreement (ELA). To facilitate DON-wide maintenance and life cycle support of the DON Microsoft technology environment and mitigate risks, all products licensed from Microsoft shall be supported by, and include, SA on an ongoing basis. Compliance will be monitored through the DON Enterprise Architecture reviews (reference (e)) as well as the DON Information Technology Expenditure Approval Authorities (ITEAA) processes initiated under reference (f).
