Subject: Fiscal Year (FY) 2017 Rates for Technical Service Center (TSC) Work

The TSC billable labor rates for FY 2017 are shown in the attached table.

We continuously strive to manage the TSC's costs to keep our rates as low as possible for our customers and are grateful for the outstanding support we have received from you in the form of an extremely strong current and projected workload. While the base rate has increased about 3 percent, we have eliminated premium rates on two of our groups, and reduced or eliminated premium service fees for several groups.

For FY 2017, contracts and acquisition costs are being included in TSC service agreements to enhance the tracking of the full cost of these integrated services. To capture the acquisition costs, we will ask the procurement folks to charge their efforts to a TSC account, and TSC will charge a fee to the customer account to recover the procurement costs. To break even, we anticipate the fee to be 15 percent of the procurement award. We will also be adding a 5 percent fee to cover financial processing of service agreements for other agencies.

The TSC is committed to providing the technical services Reclamation needs to carry out its mission. We look forward to working with you to ensure the services we deliver represent the best possible value for all of our clients in FY 2017 and beyond.

The TSC base rates for fiscal year (FY) 2017 are shown in the following table. The TSC will continue charging for services using billable rates for three skill levels.
