The purpose of this letter is to notify you of the Fiscal Year 2013 appropriations for the U.S. Fish and Wildlife Service (Service) which includes \$45,720,189 for the State Wildlife Grant program authorized by the Department of Defense, Military Construction and Veterans Affairs, and Full-Year Continuing Appropriations Act of 2013, PL 113-6.

The FY 2013 apportionment includes \$1,380,220 in reverted FY2008 funds and \$627,825 in unobligated balances from 2007 and prior year grant closures. Total funds available for the States and territories in the FY 2013 apportionment are \$47,728,234 (CFDA No. 15.634).

This program provides grants for the development and implementation of State programs to benefit wildlife and their habitat. The apportionment shown on the enclosed table is for the fiscal year beginning October 1, 2012, and is available for obligation until September 30, 2014. After this date, the Service will reapportion any remaining unobligated and other reverted funds to all States and territories, together with any new funds appropriated for FY 2015.

The funds are distributed through an apportionment formula in accordance with the Appropriations Act to States and to the District of Columbia, the Commonwealth of Puerto Rico, Guam, the United States Virgin Islands, the Commonwealth of the Northern Mariana Islands, and American Samoa. The formula for apportionment is based one-third on the land area of each State and two-thirds on the population of each State. In accordance with the Act, no State may receive less than one percent of the total available for apportionment and no more than five percent. The District of Columbia and the Commonwealth of Puerto Rico may each receive no more than one-half of one percent of the total, and Guam, the United States Virgin Islands, the Commonwealth of the Northern Mariana Islands, and American Samoa may each receive no more than one-fourth of 1 percent of the total.
